Projections for next year will be completed soon. Extended School Year is already in planning stages. Elementary sites for SH only will be at Harding and Collins. Mild to moderate classes will be at their regular summer school sites. DeJean will be site for middle school, and high schools will focus mainly on credit recovery.

Funding structure for special education may change under the Governor's budget. Currently it's distributed through SELPAs but the Governor wants funding to go through LCAP.
