WCCUSD Solar Energy Plan Community Meetings- Lisa LeBlanc

As communicated to the Facilities Subcommittee, the District recently issued a Request for Proposals for a district-wide solar project which could result in significant annual savings to the District. On May 25, 2016, staff anticipates recommending to the Board of Education a solar contract involving several sites. The solar projects would be constructed over a one-year period that would include solar carports and outdoor shade structures. Three-Year New Comers Demographics- Wendell Greer

The RAP Center has created a three-year comparison of new comer students entering WCCUSD. The Newcomer Demographic report is now available at the district level. A newcomer is defined as a student who has been in the United States for less than one year. In this report, current 2015-16 demographic data includes students who have a US entry date between October 1, 2013 and October 1, 2015. October 1st is also used as the cutoff date for 2012-13 through 2015-16 data. Data on this report includes disaggregation by ethnicity, gender, birth country, home language, fluency status and grade level. This report was produced on May 2, 2016 using information based on PowerSchool data as of May 2016. See attachment.




3 – YEAR NEWCOMER DEMOGRAPHICS




