Special Education Staffing 2015-16 – Steve Collins

Due to the short supply of credentialed special education teachers, aggressive recruitment for 2015-16 occurred early during the 2014-15 school year. We decided that we needed to go back to the Philippines to recruit special education teachers for the 2015-16 school year. In February 2015, Darlene Almeida, Coordinator, Special Education went to the Philippines to get a head start on other districts recruiting abroad. The teachers that we hired were supposed to arrive the end of July. Unfortunately, due to visa issues, the first group arrived on August 18, 2015 (six teachers). The second group that were supposed to arrive on August 19, 2015, now have been delayed until August 26, 2015 (10 teachers) and the final group, which were supposed to arrive the week of August 31, 2015 have been delayed to the middle of September. Human Resources has secured substitutes for the vacancies until their arrival.

New Visual: WCCUSD's Apple Tree of Life Infographic - Nia Rashidchi

This week's Friday memo features a new Infographic that we shared with the site Instructional Leadership Teams during the Instructional Leadership Team Academies on Monday, August 17 (secondary) and Tuesday, August 18 (elementary). We have lots of wonderful work happening in our district. Many times we get asked the question, "How do all of these pieces fit together?" This new visual was created to help explain to all WCCUSD stakeholders how our actions, services, initiatives, work, and support all fit together to ensure that our students are college and career ready, able to make <u>life</u> choices with positive and productive outcomes. The *Apple Tree of Life* helps to tell the story of how we work in WCCUSD.

Major Elements of the Graphic:

> Top left side = WCCUSD has to work with federal, state, and local legislation, policies and procedures; sometimes that legislation feels good (sunshine) and other times it does not (rain), but rain or shine, we work through it.

- ➤ Bottom left side = On the ground level, we soak up all that rain and sunshine, and we have developed the LCAP. The LCAP tells the story of how we will spend the LCFF dollars to improve student achievement.
- ➤ Bottom right side = On the ground level is also the district office who exists to support sites to do the critical daily work of improving Teaching and Learning to achieve better outcomes for kids.
- ➤ The roots of the tree include a variety of support programs, initiatives, and services that are funded by LCFF and other sources.
- ➤ Top of the tree = Our overarching district theme is *Whole Child*, *Whole Community*; we want to serve the whole child, and it takes a village.
- > Trunk of the tree & top right side = Our overarching district goal is to become a Full Service Community School District that ensures our students are college and career ready able to make life choices with positive and productive outcomes
- ➤ Multiple smaller tree branches/leaves = Student learning, student learning...we are all about students and student learning.
- Truck content = Student learning is our data both at the school and district level.
- ➤ Major 3 tree branches = The daily work that schools do falls into three major buckets: Social Emotional, Academics, and Stakeholder Involvement. The schools know these buckets well
- ➤ Top Tree Center = The ongoing work at the school is to set goals (based on a needs analysis), make a plan, take action, collect and analyze data to determine effectiveness and keep moving through a continuous cycle of improvement.
- ➤ Bottom left side = The district office also carries out the same continuous cycle of improvement.
- ➤ Overall message, we do this work together to ensure that when students leave our Pre-K 12 doors, they are college and career ready able to make <u>life</u> choices with positive and productive outcomes. The *Apple Tree of Life* helps us to tell our story.

Adult Education Updates – Wendell Greer

- WCCAE Open House, August 22, 2015 West Contra Costa Adult Education will host its Annual Open House on Saturday, August 22, 2015 from 9:00 a.m. to 2:00 p.m. at the Serra Campus. Community members, teachers, continuing students, and new students are invited to attend this exciting event. Participants will learn about our course offerings, meet instructors, and register for classes. We will also have our Counselor available to support students who are interested in participating with our High School Diploma or GED program. Light refreshments will also be available.
- New CNA Program In order to support the professional needs of our community, Adult Education is proud to announce our new CNA program. Students will engage with coursework which will prepare them for passage of the state licensing exams. The courses are designed to give our students access to current practices in the nursing field. Our community members interested in working in hospitals, nursing homes, or serving as home health aides will begin their professional journey with our exciting program.
- *Technology Update* The Computer Lab at Serra has been updated with new machines and software to assist students with their learning in our High School Diploma Program.

Students will begin the fall semester with access to the new PLATO software in our Computer Assisted Lab (Cal Lab). This new software is designed to support students with content mastery through interactive lessons. Teachers will receive academic data reports which will support them with tailoring the classroom instruction to meet the needs of our students who have diverse academic needs.

- Registration Reopened at Alvarado Campus Students who would like to register for classes are now able to register at the Alvarado campus with a credit or a debit card with the VISA or MasterCard logo. The Alvarado Campus and the Serra Campus offer students in person support at the counter or students can utilize the Kiosk stations in the lobby.
- ASA-(Administrative Software Applications) West Contra Costa Adult is upgrade to the Version 3 of our Administrative Software. The new software features upgraded accounting functions, detailed student data reports, and other tools that teachers can access to support them with their attendance collection.

SBAC Results Delayed by the California Department of Education – Nicole Joyner

The Smarter Balance Assessment Consortium (SBAC) assessments were administered to 95.9% of students district-wide in an online format in English-language Arts and Mathematics. Score reports were originally scheduled for release in August. However, the California Department of Education has delayed the release of scores until September at the earliest. Spokeswoman Pam Slater explained in an August 13 interview with the Orange County Department of Education that the delay will allow the CDE to adequately test and review the new reporting website. According to Slater:

This is the first year of scoring and reporting the new Smarter Balanced assessments, and the development of a new public reporting website. We definitely are aware of the great interest in these results and are working as quickly and diligently as possible. We are being especially careful in this inaugural year to make sure everything is handled properly. It's actually quite exciting to be at this stage, and we're looking forward to a successful launch next month.

We are taking an abundance of caution to ensure that the substantial amount of data we are receiving is properly collected and placed in new files on a new site. Additionally, the department will be launching a new website to display the results and needs sufficient time to test the new site.

Once the scores are released, the WCCUSD Accountability & Assessment Department will send score reports to parents / guardians and school sites. School-level results will also be available to staff in Illuminate, and district-level results will be shared to the public on the data dashboard.

WCCUSD School Nutrition Program Administrative Review - Lisa LeBlanc

The California Department of Education Nutrition Services Division performs an Administrative Review of all school food authorities participating in the National School Lunch Program and/or School Breakfast Program over a three-year cycle. During the 2014/15 school year WCCUSD received its administrative review which consists of three phases: pre-review, on-site review, and post-review. This past year, Food Services has collaborated to complete the Administrative Review to ensure program integrity, compliance and to determine if all Federal and State School Nutrition Program requirements are met. The review did identify findings regarding meal components, eligibility verification, signage, point of service and the implementation of the USDA Non-Program Food Revenue Tool. The findings are not significant and corrective actions have been implemented including staff being retrained and procedures changed to meet state requirements. None of the findings resulted in fiscal action.

Board Consideration of Mr. Dennis Hicks to the Citizen's Bond Oversight Committee (CBOC) – Lisa LeBlanc

On August 12, 2015, the Board tabled the consent item recommending Mr. Dennis Hicks as the appointee of the Contra Costa Building and Construction Trades Council for a 2-year term. CBOC attorney Mr. Adam Ferber describes a mechanism by which members of the CBOC whose terms have expired or will soon expire may continue to serve while the Board of Education considers, and how, the size of committee might be reduced in response to the Grand Jury Report. He suggests that until the Board takes final action to reduce the size of the CBOC, it appoint committee members to renewal terms of less than the regular two-year term. Board Policy 7214.2 empowers the Board to appoint individuals to the CBOC for two-year terms. In his opinion, the power to appoint for a two-year term also includes the power to appoint a member for a term of less than two years. Exercising the Board's power to appoint in this way will permit a continued continuity in the business of the CBOC until a Board decision has been appropriately vetted and has been made final. The reduced renewal term of any CBOC member can be created by the Board in either of two ways: (a) The Board can make the appointment and provide that it shall expire at the sooner of either of these events: (1) the completion of the twoyear term, or (b) upon a final decision by the Board to eliminate that category of membership from the CBOC; or (b) The Board can make the appointment for a fixed term of less than two years, with a fixed expiration date. The choice of a fixed date can be based on the estimate of the Board or its staff concerning when Board deliberations regarding the reduction of overall CBOC membership is expected to become final.
