The Provisional Internship Permit (PIP) was created in response to the phasing out of emergency permits and became effective on July 1, 2005. It allows an employing agency to hire an individual who has not yet met the subject matter competence requirement needed to enter an internship program. Prior to requesting a PIP, the employing agency must verify that a diligent search has been made, and a fully credentialed teacher cannot be found. The PIP is issued for one (1) year and is renewable one time only provided the teacher has taken all appropriate subject matter examinations, but has not yet passed those tests.

*CI G.13 Ratification and Approval of Negotiated Change Orders

Comment:

Staff is seeking ratification of Change Orders on the following current District construction projects: El Cerrito HS Admin/Theater, El Cerrito HS New Campus, Helms Middle School New Campus, Pinole Middle School New Gym/Classroom Building, and DeAnza HS Track and Field projects. Change Orders are fully executed by the District upon signature by the Superintendent's designee. Board ratification is the final step required under state law in order to complete payment and contract adjustment.

Fiscal Impact: Total ratification by this action: \$811,873.36.

*CI G.14 Ratification and Approval of Engineering Services Contracts

Comment:

Contracts have been initiated by staff using previously qualified engineering, architectural, or landscape architectural firms to assist in completion of the referenced projects. Many of the firms are already under contract and the staff-initiated work may be an extension of the firm's existing contract with the District. Public contracting laws have been followed in initially qualifying and selecting these professionals.

Recommendation: Ratify and approve contracts

*CI G.15 Ohlone Elementary School Architects Award of Contract and Approval of Fees

Comment:

The next step in completing the Measure J Master Plan Renovations at Ohlone Elementary School is to retain the architects to complete construction documents for the New Construction, Temporary Housing, Renovations, and Sitework portions of the project. The District's architects for Ohlone Elementary School are Powell and Partners + HMC Architects. They have worked closely with the Ohlone Elementary School staff to develop the Master Plan for the site. The Board approved the Master Plan in April of this year. Since that time, the firms have been completing background work and meeting with the site to develop the Schematic Design work on the project. The District and the firms have negotiated an

agreement for fees that is in keeping with fees on other District projects, but which reflects also the complex phasing requirements of the project.

Recommendation: Award architectural contract and approve fees.

Fiscal Impact: \$2,659,730. Projects will be funded from the Measure J Bond.

*CI G.16 Kennedy High School Exterior Painting Project Award of Contract

Comment:

The first project in the Kennedy High School Renovations is the exterior painting of all of the campus buildings. This project is a high priority for the staff and is associated with creating a better campus environment for students and a more positive image of the campus to the community. The project includes minor building repairs, surface preparation, painting of the buildings and all trim. The project also includes repairs and sealing of the stone panels. HMC Architects, in association with Powell and Partners, has prepared plans and specifications for the project. The project will take place during the school year, when students and staff are present. The project manual includes instructions for after hours and weekend work for areas which would impact the educational program. The District is currently conducting a public bid process. Bids are due to be opened on August 19, 2008. Staff will bring a recommendation for award to the meeting of August 20, 2008.

This item is being presented prior to the expiration of the five working day Bid Protest period. In consideration of this timing and in order to expedite the project, the Board's action will be to authorize staff to issue the Notice of Award effective at the end of the Bid Protest period to the lowest responsive, responsible bidder. This award by staff will then be brought back for ratification at a future meeting.

<u>Recommendation:</u> Authorize staff to issue Notice of Award upon successful completion of the Bid Protest period.

<u>Fiscal Impact:</u> \$_____. Projects will be funded from the Measure J Bond.

*CI G.17 YMCA-East Bay, Peres Lease Agreement

Comment:

Staff is recommending approval of the lease agreement between West Contra Costa Unified School District (Lessor) and YMCA - East Bay (Lessee). The agreement will provide for the right of the Lessee to use land space, suitable for the location of (6) six portable classrooms. Lessee owns (5) five portable structures and District (Lessor) owns (1) portable structure, which are located adjacent to the Peres Elementary School site, 719 5th Street, Richmond.

Lessee shall use the portable classrooms for the operation of a before and after school "Child Care" program for elementary school-aged children. YMCA-East Bay shall not use the premises for any other use without District's consent. The lease term will be three (3) years, commencing on the effective date.

Recommendation: Recommend Approval

Fiscal Impact: Yearly revenue of \$7,200.00.

*CI G.18 Compliance with the California Environmental Quality Act: Adopt Resolution 19-0809 Authorizing Adoption of a Mitigated Negative Declaration and Mitigation Monitoring and Reporting Plan for and approval of the Ford Elementary School Temporary Relocation to Downer Project

Comment:

District staff retained PMC to prepare a study under the California Environmental Quality Act ("CEQA") to evaluate the possible environmental impact of the proposed Ford Temporary Campus at Downer Elementary School. PMC prepared and issued an Initial Study in June 2008. As part of the Initial Study, the consultants completed a traffic analysis of impacts at the Downer site. The District issued the Notice of Intent to Adopt a Mitigated Negative Declaration on June 30, 2008. The 30 day Public Comment period ended on July 29, 2008. The District has received two (2) written comments to date: one from the Dept. of Toxic Substances Control ("DTSC") and one from a neighbor of the Downer Elementary School site. The District is responding to DTSC's requests for further reviews and to the comments raised by the neighbor. These responses are included in the record. In the event that the District receives any further written comments prepared prior to the termination of the public review period, the written comments and District's written responses to the comments, if any, will be made a part of the record at the Board meeting.

The Mitigated Negative Declaration is provided under separate cover with the proposed resolution along with proposed mitigation measures which will mitigate any environmental impacts from the Project to a level of insignificance. The Board recommendation includes the Initial Study, the Mitigated Negative Declaration; and to the extent that any written comments are timely received, then the written comment, and the response to comments, if any, will be made a part of the Mitigated Negative Declaration. These documents form the final Mitigated Negative Declaration.

<u>Recommendation:</u> Adopt Resolution 19-0809 Authorizing Adoption of a Mitigated Negative Declaration and Mitigation Monitoring and Reporting Plan for and Approval of the Ford Elementary School Temporary Relocation to Downer Project.

<u>Fiscal Impact</u>: Full fiscal impact not known. Future projects will be bid. Projects will be funded from the Measure J Bond.
