## \*CI C.12 Ratification and Approval of Engineering Services Contracts

## \*CI C.13 Ratification and Approval of Negotiated Change Orders

#### Comment:

Staff is seeking ratification of change orders on the following current District construction projects: Madera Elementary School Site Work for Portables, Kennedy High School Concession Stand and Lights, and El Cerrito High School Multi-Purpose Sport Field. Change orders are fully executed by the District upon signature by the Superintendent's designee. Board ratification is the final step required under state law in order to complete payment and contract adjustment.

In addition to normal ratification, approval of the noted change order for the Kennedy High School Concession Stand and Lights and El Cerrito High School Multi-Purpose Sport Field projects are required by the Board, with special findings as noted below, because these projects are in excess of the Public Contract Code limit of 10% of the original contract value. In accordance with Public Contract Code Section 20118.4, the Board, by approving and ratifying these change orders, finds that it would have been futile to publicly bid the work in question because of the tight time frames to complete this work without affecting the operations of the District, and that the public is best served by having this work completed by the contractor on the project.

<u>Recommendation</u>: Ratify negotiated change orders as noted

<u>Fiscal Impact</u>: Total ratification and approval by this action: \$99,825.14

## \*CI C.14 Joint Use Agreement between the District and the City of El Cerrito for the use of Recreational Facilities for Portola Middle School

## Comment:

The District is in need to continue the use of the Cerrito Vista Park Recreational Facilities for Portola Middle School students and staff members for physical fitness programs throughout the school year. The City of El Cerrito has agreed to allow the District to use the park facility on a temporary basis until the completion of the construction of the new school site.

The proposed agreement with the City of El Cerrito provides for a legal framework to allow the use of the Park facilities. The agreement is attached and has been reviewed by District's legal counsel. It is being concurrently reviewed and approved by the City of El Cerrito. This agreement was approved by the Facility Subcommittee on December 13, 2011.

<u>Recommendation:</u> Approve the use Agreement with City of El Cerrito.

<u>Fiscal Impact</u>: Project will be funded from the Measure D 2010 Bond, \$10,000.

## \*CI C.15 Nystrom Elementary School Temporary Campus Modulars Award of Contract

#### Comment:

The first phase of the reconstruction of Nystrom Elementary School is the construction of a temporary campus to house the school during construction. Interactive Resources has prepared plans and specifications for the Nystrom Elementary School Temporary Campus Project. The work includes delivering and setting up modular units and ramps for the project.

The District engaged in a public bid process for the project. Bids were opened on December 19, 2011. Two contractors submitted bids. They are as follows: Mobile Modular, \$637,288; and WM Scotsman, \$889,662. The apparent lowest bidder is Mobile Modular.

#### Recommendation:

Award contract to the lowest responsive, responsible bidder upon the expiration of the protest period.

Fiscal Impact:

Total for this action: \$637,288. Measure J Bond.

## \*CI C.16 Pinole Middle School Interim Housing Demolition Project

#### Comment:

The Pinole Middle School Interim Housing Demolition Project consists of demolishing the portables, including ramps, stairs, landing with handrails, foundation and utility connections, shutting off and capping water, gas and sewer lines, removing and relocating utilities, and constructing a new temporary fence and gate at Pinole Middle School.

The District engaged in a public bid process for the project. Bids were opened on November 29, 2011. Six contractors submitted bids. They are as follows: Thomas D. Eychner, \$155,000; Kin Woo Construction, \$189,000; Abestos Management Group, \$199,875; ERA Construction, \$212,000; CF Contracting, \$218,000; and S&H Construction, \$229,500. The apparent lowest bidder is Thomas D. Eychner.

<u>Recommendation</u>: Award contract to the lowest responsive bidder

<u>Fiscal Impact</u>: \$155,000. Funded by the Measure J Bond

## \*CI C.17 Richmond High School Fiber Optics Project

## Comment:

The Richmond High School Fiber Optics Project consists of installing fiber optic cable and conduits, including installing cable from the Administration Office to the Art Room, Music Room and portable classroom on the south each corner of the main campus, as specified in the contract documents specification and drawings.

The District engaged in a public bid process for the project. Bids were opened on September 22, 2011. Three contractors submitted bids. They are as follows: Nema Construction, \$48,000; Eclipse Electric, \$59,761; and ERA Construction, \$62,000. The apparent lowest bidder is Nema Construction.

<u>Recommendation</u>: Award contract to the lowest responsive, responsible bidder.

Fiscal Impact: \$48,000. Funded by the Measure J Bond.

## \*CI C.18 Approval of Increase in District Allocation for Maritime Center Renovations Project

## Comment:

The Board approved full participation in the Maritime Center Renovations project as a part of the District's Proposition 39 Equivalent Charter School Facilities offer to the Richmond Children's Foundation for the Richmond College Prep ("RCP") Academy. RCP will use 4 classrooms and associated administrative space in the building. The District has made a contribution of \$2 million dollars to the project. These funds were also matched by a contribution from the City of Richmond of \$500,000. The Rosie the Riveter Trust is funding the remainder of the project through state historic preservation grants and tax credits.

The project involved renovating and restoring the historic Maritime Center, a Daycare Center for shipyard worker families during World War II. The project also included a component of the building being occupied by the National Park Service with a restored classroom and interpretive exhibit. The building is eligible for the National Register of Historic Places.

The construction project has been difficult and faced numerous challenges related to unforeseen conditions, hazardous materials removal issues, structural repairs, rain delays, and utilities issues. The Rosie the Riveter Trust has requested that the District provide an increase in its commitment in order to help overcome the added costs during construction and in the project close-up. The Rosie the Riveter Trust has requested that the District make an additional contribution up to but not exceeding \$250,000.

## Recommendation:

Approve increase in District allocation to Maritime Center project.

Fiscal Impact:

\$250,000. Funded by the Measure J Bond under the Richmond College Prep Charter School budget.

## \* D.1 Report on the Advanced Placement program in West Contra Costa Unified School District

## Comment:

We would like to acknowledge 34 seniors who were designated AP Scholars during the last year's AP Exam administration in May 2011. There are four levels of AP Scholars:

1. AP Scholars - Granted to students who receive 3 or higher on three or more AP Exams.

- 2. AP Scholar with Honor Granted to students who receive an average score of at least 3.25 on all AP Exams taken, and scores of 3 or higher on four or more of these exams.
- 3. AP Scholar with Distinction Granted to students who receive an average score of at least 3.5 on all AP Exams taken, and scores of 3 or higher on five or more of these exams.
- 4. National AP Scholar Granted to students in the United States who receive an average score of at least 4 on all AP Exams taken, and scores of 4 or higher on eight or more of these exams.

A report on the status of the AP programs will also be given by El Cerrito High School, Pinole Valley High School, and Hercules Middle High School. Last May, Pinole Valley administered the highest number of AP exams (431), Richmond had the highest number of AP exam takers (212), and Hercules and El Cerrito had the highest AP exam passing rate (42%).

## Comment:

Before the repayment of the State Loan the District is required to retain an auditor to confirm the District has adequate fiscal systems and controls in place. (EC 41320.1) The District retained Vavrinek Trine and Day (VTD) to complete the audit. Caroline Larson from VTD will make a brief presentation on the study. Once the Board has accepted the audit staff will present the audit to the State Superintendent of Schools with a request that the State relinquish oversight. Staff will also work with the Department of Finance and the I-Bank to determine the structure and amount of the loan pay off. The outstanding debt is held in the form of a Lease Revenue Bond issued by the California Infrastructure Bank.

## \* F.2 Public Hearing for Resolution No. 74-1112 for SB 293

#### Comment:

Senate Bill No. 293 prohibits public entities from withholding retention more than 5% of the contract price on public works contracts entered after January 1, 2012 unless certain conditions specified in Public Contract Code Section 7201 are satisfied.

Staff believes that school construction projects are of a nature that is substantially complex requiring retention in an amount exceeding 5%. The current standard for retention is 10% and staff would like to continue to use the current standard of 10% for projects deemed substantially complex.

To comply with the conditions in Public Contract Code Section 7201, staff is asking the Board to approve the resolution establishing criteria for determining whether a project is substantially complex at this properly noticed, regularly scheduled public hearing. Notice of this public hearing was posted on December 16, 2011.

In addition, staff is asking the Board to approve the resolution delegating the authority to make the determination whether a project is substantially complex to the superintendent or the superintendent's designee.
