I. CALL TO ORDER

President Madeline Kronenberg called the meeting to order at 6:00 PM.

III. BUDGET DISCUSSION

Superintendent Harter announced that this meeting would be a workshop for the Board to conduct a public discussion. He reported on the six community budget meetings held in January and February with over 700 people in attendance and said that Ms. Sheri Gamba would provide additional background at the request of the Board.

Ms. Gamba provided information regarding multiyear projections, anticipated deficit spending, expenditures, and other budget details.

Discussion ensued among Board members and staff, including the possible use of available deferred maintenance funds to transfer to the General Fund, as appropriate under state flexibility law, and review of the bond project list for deferred maintenance funds.

Ms. Rashidchi provided information regarding the use of federal funds, new Title I ARRA funds (American Recovery and Reinvestment Act of 2009) for a class size reduction (CSR) initiative. She reported that the U.S. Department of Education has approved eight waiver requests from the California Department of Education. She said that Title II funds for Highly Qualified Teachers would allow another option for use toward class size reduction, and the targeting and repurposing of federal funds to the CSR initiative. With the repurposing of funds, she indicated that other services would be given up to take advantage, including the repurposing of professional development funds, reduction or elimination of the categorical fund cushion, and that this would only be a one year solution.

Board members continued with discussion about levels of funding for class size reduction.

Ms. Gamba continued the presentation with information relating to the Adult Education Program. Mr. Greer provided information about work with the local park and recreation departments to coordinate with classes for elder adults. Superintendent Harter spoke about State funds that may subsidize adult education program costs and staffing. Discussion continued.

Ms. Gamba restated the Board's direction in dealing with the use of deferred maintenance funds for class size reductions and augmenting secondary levels, as well as the potential of a balanced budget by June for the 2010-2011 school year.

Mr. Ramsey asked staff to bring this item to the next Board meeting for the public to address. Board members were in agreement.

Superintendent Harter spoke about the Legislature dealing with 2009-10 budget deficit and the U.S. House of Representatives considering a bill that would provide additional funding for education.
