## \*CI C.9 Ratification and Approval of Engineering Services Contracts

### Comment:

Contracts have been initiated by staff using previously qualified consulting, engineering, architectural, or landscape architectural firms to assist in completion of the referenced projects. Many of the firms are already under contract and the staff-initiated work may be an extension of the firm's existing contract with the District. Public contracting laws have been followed in initially qualifying and selecting these professionals.

## \*CI C.10 Ratification and Approval of Negotiated Change Orders

#### Comment:

Staff is seeking ratification of Change Orders on the following current District construction project: Kennedy High School Painting. Change Orders are fully executed by the District upon signature by the Superintendent's designee. Board ratification is the final step required under state law in order to complete payment and contract adjustment.

In addition to normal ratification, approval of the noted Change Order for the Mira Vista Elementary Sitework project is required by the Board, with special findings as noted below, because this is in excess of the Public Contract Code limit of 10% of the original contract value. In accordance with Public Contract Code 20118.4, the Board, by approving and ratifying these Change Orders, finds that it would have been futile to publicly bid the work in question because of the tight time frames to complete this work without affecting the operations of the District, and that the public is best served by having this work completed by the contractor on the project.

In addition to the Construction Change Orders, this action includes four Changes Orders to the modular building contracts at: Ford Elementary School Temporary Campus; Leadership Public Schools Temporary Campus; Richmond College Prep Modular Campus; and DeAnza High School Temporary Campus. These changes to the approved contracts include modifications to the scope of work—for example adding buildings, changing ramps, or making interior modifications in order to meet educational program needs. Ratification and approval is required as noted.

Recommendation: Ratify and approve negotiated Change Orders as noted

Fiscal Impact: Total ratification and approval by this action: \$106,887.82.

## \*CI C.11 Approval of Architect Selection and Award of Contract for Coronado Elementary Programming and Master Planning

#### Comment:

At its meeting on June 3, 2009, the Board approved Coronado Elementary School to proceed to the Programming and Master Planning phase of work for renovation or reconstruction. The Board also directed staff to initiate an architect selection process immediately to ensure timely action on initiating the planning process at the site. Pursuant to the Board's direction, staff has initiated a selection process with the Coronado Site Committee. Three architectural firms were selected by staff for interviews at the school. The firms are all currently in the pre-qualified architect pool designated by the Board in 2006 for Measure J projects. Interviews were conducted on June 10, 2009 with the Coronado Site Committee. The recommended firm is WLC Architects.

Staff met with WLC Architects, at which time WLC provided proposed fees for Programming and Master Planning. The Architects anticipate a process which will look at a number of options for the Coronado site to allow the District flexibility for a range of budgets which may be available. The options to be reviewed will include full renovation of the existing buildings plus limited new construction to meet program requirements. As a part of this approach, the Architects will provide a prioritized menu of renovations for the District—in case limited funds are available. The team will also review options for full reconstruction of the site. It is anticipated that the work can begin over the summer with facilities assessments and background work. Intensive work with the Site Committee and community outreach is a part of the process and will be scheduled for the beginning of the next school year. It is anticipated that a Master Plan can be brought to the Board in late fall 2009.

<u>Recommendation</u>: Approve recommended architect selection and award contract for Programming and Master Planning services

Fiscal Impact: \$185,000. Funded by the Measure J Bond.

## \*CI C.12 Coronado Elementary Fence & Gates Replacement Emergency Repair Program Contract Award

#### Comment:

The District has received funding from the State Emergency Repair Program ("ERP") to replace seriously deteriorated fencing and gates at the Coronado Elementary site.

Seville Group ("SGI") prepared bid documents for the state-approved project. A public bid process was conducted. Bids were opened on May 27, 2009. Four Contractors submitted bids. They are as follows: Bailey Fence \$23,961; Golden Bay Fence \$22,900; AAA Fence \$20,249; and Chain Link Fence \$14,728. The lowest responsive, responsible bidder is Chain Link Fence at \$14,728.

Recommendation: Award contract to lowest responsive, responsible bidder

Fiscal Impact: \$14,728. Funded from the Emergency Repair Program ("ERP")

## \*CI C.13 Coronado Elementary Interior Windows, Abatement, Trim Emergency Repair Program Contract Award

## Comment:

The District has received funding from the State Emergency Repair Program ("ERP") to replace seriously deteriorated windows at the Coronado Elementary site.

Seville Group ("SGI") prepared bid documents for the State-approved project. A public bid process was conducted. Bids were opened on June 10, 2009. Four Contractors submitted bids. They are as follows: Parc Services \$774,829; Nema Construction \$630,000; Ionian Construction \$515,000; and, Pinguelo Construction \$500,907. Pinguelo Construction is the lowest responsible bidder at \$500,907.

Recommendation: Award contract to lowest responsive, responsible bidder

Fiscal Impact: \$500,907. Funded from the Emergency Repair Program ("ERP").

# \*CI C.14 Crespi Fire Reconstruction Construction Management Services Award of Contract

### Comment:

The next step in completing the reconstruction of the fire-damaged administration building at Juan Crespi Middle School is for the District to retain a project and construction management (PM/CM) team to oversee the work. At its June 10<sup>th</sup> meeting, the Facilities Subcommittee addressed the process of selecting a firm to provide PM/CM services for the reconstruction of the administration building at Juan Crespi Middle School. After a full vetting of information provided to the Board, subsequent Board actions and a discussion regarding the application of our processes, it was determined that the current qualified list should be used as the basis of the selection. The Subcommittee selected and recommended that SGI be awarded the contract.

Recommendation: Award contract to SGI

Fiscal Impact: Funded from fire insurance proceeds

## \*CI C.15 Verde Elementary Sitework Playground Renovations Project Award of Contract

## Comment:

The final step in completing the full renovation of Verde Elementary School is to upgrade the playground and complete sitework that was not finished during the main project in 2004. The scope of work includes playground asphalt repairs, play structure upgrades, new games and striping. The project also has a major site safety component with the installation of new perimeter fences and gates—including ornamental ironwork gates at the bridge entry to campus. The project also includes the installation of a new parking area adjacent to the administration building and associated security lighting, drainage and fencing.

Powell and Partners Architects prepared plans and specifications for the Verde project. The District conducted a public bid of the project. Bids were opened on June 2, 2009. Seven Contractors submitted bids. They are as follows: WR Forde \$949,000; Blossom Valley \$912,418; Bruce Carone Paving \$832,274; A&E Emaar \$825,000; Evans Brothers \$795,799; Bay Cities Paving and Grading \$726,000; and ERA Construction \$525,562. After the bid, and within the timeframe identified in the specifications, ERA Construction notified the District that there was a mathematical error in the calculation of its bid.

ERA's bid was withdrawn with the concurrence of the District. The lowest responsive, responsible bidder is Bay Cities Paving and Grading at \$726,000.

<u>Recommendation:</u> Award contract to lowest responsive, responsible bidder

Fiscal Impact: \$726,000. Funded from the Measure J Bond.

# \*CI C.16 School Consolidation Moving Services Contract Awards

# Comment:

A major element of the School Consolidation process is moving teachers, staff, and school contents from the three schools being closed to newly assigned sites. These are complex moves, with each of the closed sites sending teachers, staff, and contents to a number of different locations. The District's School Consolidation Team prepared bid documents which would give the District flexibility in the moves by circulating request for proposals based upon costs for unit prices to move a closing sites' contents to any location within the District. For example, the proposals request each firm to provide costs for: a four-person crew + supervisor for 8 hours; a standard mid-sized moving truck + fuel for 8 hours; and costs for boxes and labels.

Proposals from the moving companies were received on June 9, 2009. Seven moving companies submitted proposals. When ranked on the basis of total cost of Crew + Truck, the proposals are as follows: Mayflower \$2,470; Cor-o-van \$1,596; Doubleday \$1,577; Valley Relocation & Storage \$1,532; Chipman \$1,520; Crossroads \$1,486; and, Moving Solutions \$1,168. The lowest unit price mover is Moving Solutions at \$1,168 per day for Crew and Truck.

The total number of moving days is not known exactly, however, it is anticipated that there may be up to 40 total moving days needed under this contract. That would result in a total cost of just under \$50,000 for the base contract. Additional time may be needed depending up moving complexities at the sites.

Recommendation: Award contract to lowest unit price mover

<u>Fiscal Impact:</u> Base Contract Crew + Truck and boxes/labels, not to exceed \$50,000. Funded from the Special Reserve for Capital Outlay (Fund 40).

# \*CI C.17 Revised Board Policy BP 6164.6 – Identification and Education Under Section 504

## Comment:

On September 25, 2008, President Bush signed into law the American with Disabilities Amendments Act of 2008, which became effective on January 1, 2009. The act expanded the scope of disabilities covered under the Americans with Disabilities Act ("ADA") and Section 504 of the Rehabilitation Act of 1973 ("Section 504") as well as the protections available to students.

There are three key provisions of the Act that impact school districts as educators in terms of their responsibilities under the ADA and Section 504: (1) the definition of "disability" is expanded; (2) "major life activities" are clarified and expanded, and (3) most mitigation measures may no longer be considered in disability determinations.

Due to this the district's Section 504 policies, procedures, training materials, manual and forms had to be revised.

### Recommendation: Board Approval

# \*CI C.18 Approval of Board Member to Attend California Latino School Boards Association (CLSBA) Conference

### Comment:

Board Bylaw 9250 stipulates members of the board shall be reimbursed for allowable expenses incurred in attending any meetings or in making any trips on official business of the school district when so authorized in advance by the Board of Education. (Education Code 35044). Board member Antonio Medrano has expressed an interest in attending the California Latino School Boards Association Unity 2009 Conference. Expenses including registration, fees, travel, food and lodging are estimated to total approximately \$750.00. Funds for Board travel and conference are budgeted and there is sufficient funding within that budget.

Recommendation: That the Board authorize member Antonio Medrano to attend the CLSBA conference.

Fiscal Impact: \$750.00. General Fund.

## \*CI C.19 Resolution 98-0809 in Support of 55% Parcel Tax Threshold

#### Comment:

SCA 6 (Simitian) places a constitutional amendment on the ballot in 2010 to ask voters if they support school districts having the ability to pass local parcel taxes with a 55% vote threshold instead of the current two-thirds. This would make the vote threshold for parcel taxes the same as for local general obligation bonds for school facilities.

<u>Recommendation</u>: That the Board adopt Resolution No. 98-0809 in support of lowering the parcel tax threshold to 55%

The severe reductions in State funding for public education in California have had and are having a significantly negative impact on educational services in the West Contra Costa Unified School District. The Board has had to reduce programs, eliminate services and layoff staff in order to absorb reductions in funding for 2008-09 and those projected for 2009-10. Many districts have concluded that the only sustainable way to fund public education is through local options that require voter approval.

At the May 20, 2009 meeting, the Board discussed a possible parcel tax as a means to supplement the declining state funding.

<u>Recommendation</u>: That the Board appoint two members as a parcel tax subcommittee and authorize the issuance of a request for qualifications for a parcel tax consultant

# F.8 Resolution No. 97-0809: Resolution to Decrease the Number of Certificated Employees Due to a Reduction in Particular Kinds of Services

## Comment:

During the time period between five days after the enactment of the Budget Act and August 15 of the fiscal year to which the Budget Act applies, if the governing board of a school district determines that its total revenue limit per unit of average daily attendance for the fiscal year has not increased by at least 2 percent, Education Code section 44955.5 provides a school district with the ability to decrease the number of probationary or permanent certificated employees.

Pursuant to Education Code Section 44955.5 the District must adopt a resolution to reduce or eliminate particular kinds of services and notice the appropriate certificated staff, in accordance with the schedule adopted by the Board on June 3, 2009. This action is recommended in order to meet the necessary budget reductions for the 2009-2010 school year.

# F.9 District Data Warehouse System and Services

# Comment:

\*

The District accumulates vast amounts of operational and educational data that is stored in separate "information silos." District data sources include, but are not limited to: PowerSchool (replaces SASI) Student Information System, Encore (SPED), Edusoft, STAR, State Test Results, CAHSEE, SAT, Advanced Placement, Follett, Blackboard Connect Ed, Food Services (Winsnap), English Learner Services, Bi-Tech and School Dude. Business and operational information systems, like Bi-Tech and School Dude, do provide the information (data) needed to run the day-to-day operations of the District; but what is needed is for all these different kinds of information to be readily available and integrated at one location to make strategic decisions. Sometimes a particular department (ITS, Finance, SPED, Assessment, Educational Services) or school can produce ad hoc reports from a single application. But in most cases, the reports need data from multiple systems, requiring the writing of extract programs to create intermediary files that could be used to produce the ad hoc reports. This process is very labor intensive, requiring specialized technological skills.

Implementation of the District Data Warehouse System and Services will provide the data needed for strategic decision making and is available in an interactive manner. District employees will be able to query online and get results. The information will be in a format suitable for analysis. The data warehouse is a simple concept involving different functions: data extraction, data loading, transforming the data, storing the data, and providing easy-to-use (and friendly) user interface.

This project also follows a key recommendation from the NCEA (National Center for Educational Accountability) report.

Recommendation: Approve implementation of the District Data Warehouse System and Services

<u>Fiscal Impact:</u> \$500,915.00 for software, hardware, installation, and one year's software maintenance cost. Funding source: Microsoft voucher money

# F.10 Consolidation of Adult Education Administration

## Comment:

\*

On February 11, 2009, the Board approved a school closure plan that included moving the Adult Education operations into a single facility at Kennedy High school for the 2010-11 school year. A few days later the California Legislature adopted a 2009-10 budget that essentially eliminated categorical funding for a host of programs including Adult Education. On April 1, 2009, the WCCUSD Board approved transfer of categorical funds from the "Tier III" programs including Adult Education to the general fund of the district.

In order to reduce overhead expenses and put the maximum available resources into programs for the adult population, district staff made plans to consolidate the administrative functions of the Adult Education facilities into a single site at Alvarado. Staff conducted a comparison of the two sites on four dimensions: space availability, access to public transportation, expenditures for site improvements and security. In each dimension, Alvarado was found to be more suitable than the Serra site.

Since Adult School programs are offered at schools, senior centers and community centers, the classes that have been at Serra and that will remain after the program reductions will be offered at other facilities in the central part of the school district including Mira Vista, Riverside, Ford, Grant and Wilson Elementary schools and Helms Middle school as well as in other community centers and other facilities.

<u>Recommendation</u>: That the Board approve the closure of the Serra facility

Fiscal Impact: Operating savings of \$85,000 annually

- 2. What level of planning and detail does the Board require in consideration of new initiatives that come before the Board either from individual Board members, the public or as a result of a recommendation from a subcommittee of the Board? Does the Board require a detailed plan, timeline and funding source? Given the sharp decline in resources for current initiatives, will the Board add new initiatives without eliminating previous ones?

<u>Recommendation</u>: That the Board discuss the process used for establishing the Board meeting agenda and provide direction about modifications to the Bylaw that would be brought back to the Board at a subsequent meeting.

Public Comment: Luis Perez, Cheryl Maier, Roberto Reyes

#### **Board Comment:**

Mr. Thurmond spoke about the context of the number of identified homeless students in the district being equal to the enrollment of some schools. He asked the team to let the Board know what support is needed to continue their efforts in tough economic times and thanked them for continuing the work to keep resources flowing.

Ms. Kronenberg said that as an adult education teacher, she has students that have lost homes. She said that this program is a safety net for many families and acknowledged their work as well as support from the City of Richmond.

Mr. Medrano spoke about housing foreclosures in West County and concern for students of displaced families. The work of churches and community organizations supports the Nevin Community Center and the Families in Transition program. He commended Ms. Cohen for her work.

Ms. Miles thanked Ms. Cohen for all her work and spoke of lifelines provided to the community.

Mr. Ramsey said the presentation was informative and expressed willingness to assist young people placed in unfair situations. He said that without assistance, many talented young people won't reach their full potential. He thanked Ms. Cohen for bringing awareness to the public.

#### D.7 Richmond Tales: The Lost Secrets of the Iron Triangle

Ms. Mallon and Marin Trujillo presented copies of the book *Richmond Tales: The Lost Secrets of the Iron Triangle* to Board members. The book was created through a partnership with Community Works, West County Reads, and adults who care about children's literacy. This began as a project to support summer learning with a book about Richmond and characters similar to the children of Richmond. With limited funding, the book has been delivered to all 4 and 5<sup>th</sup> graders in the district. Ms. Mallon presented an overview of the book and Debbie Grisso from the Curriculum Department presented the activity guide to accompany the book. Author Summer Brenner spoke about the community inspiration for her book and advocating for literacy.

Ms. Miles offered congratulations to both schools.

Ms. Gamba provided an update of information for the 2008-09 and 2009-10 budgets with developments since the failure of the May ballot initiatives.

Mr. Ramsey asked a procedural question regarding the Third Interim Report, 2008-09. Ms. Gamba and Ms. Romeo provided clarification.

#### **Board Comment:**

Ms. Miles clarified that Bond funds can only be spent on facilities.

Mr. Thurmond commented on a recent discussion with federal Secretary of Education Arne Duncan and federal stimulus funds. Superintendent Harter responded. Mr. Thurmond had follow-up comments about what the district should do to determine ways to save programs and minimize costs, developing a proactive conversation with stakeholders.

Mr. Medrano commented about meeting with the Secretary of Education and the broken educational system of California. Mr. Medrano urged support of legislative efforts to address the state budget in Sacramento.

Ms. Kronenberg asked questions about proposed adult education funding reductions and federal funding. Ms. Gamba responded. Ms. Kronenberg spoke about the procedure and proposals considered in Hayward Unified School District and asked for funding information for a similar approach in this district.

Mr. Ramsey asked for proactive solutions to give people something constructive to do in order to deal with fears.

Mr. Medrano commented about ESL programs at Contra Costa College and schools in the flatland areas of Richmond.

Mr. Thurmond asked Superintendent Harter for his thoughts on putting together a workgroup to determine strategies for cost reductions. Dr. Harter responded that the majority of the district budget is tied up in benefit and employee related costs, salary roll backs, furloughs, and cuts to medical benefits. Mr. Thurmond continued to discuss key stakeholder participation to get through difficult times.

#### D.9 In Memory of Members of the School Community

Superintendent Harter recognized the contributions of community members who have passed away and followed with a moment of silence.

#### D.10 Standing Reports

**Citizens Bond Oversight Committee**: Sue Pricco, chairperson, asked members in attendance to join her at the podium to announce the next meeting, June 17 at Ohlone Elementary School in Hercules. A tour of the campus will take place prior to the meeting. She said the members of the committee feel strongly about resuming publication of the WCCUSD Reporter.

**Public Employees Local One**: Richard Leung, Supervising Business Agent, spoke about distress at the district's position to cease the coalition of union's interest based approach to bargaining regarding benefits. He said that classified employees are not unsympathetic regarding the current budget situation faced by the district.

**Community Budget Advisory**: Charles Cowens reported that the next meeting will be held June 18, 6:30 p.m. at Alvarado Adult School. He also spoke about the upcoming Board Governance retreat on June 6.

Academic Subcommittee Report: Ms. Nia Rashidchi provided a review of a recent meeting where discussion took place regarding an update on equity initiatives, an LEA plan update and current mentoring programs. The next meeting will be held on June 23<sup>rd</sup>. Mr. Thurmond asked a question about the mentoring program that was referred to the Academic Subcommittee from a recent Board meeting and outcome of committee's review. Ms. Miles responded that the committee asked Mr. Greer to determine funding and also asked that a clear proposal be drafted and brought back to the committee for further discussion. Mr. Greer said that further information regarding current mentoring programs will be brought to the June 23<sup>rd</sup> meeting. Mr. Thurmond asked that as author of the resolution, he be provided information and asked that the committee review to bring to the Board for action in a timely manner to take advantage of potential federal funding. Mr. Ramsey asked whether the Youth Commission was discussed at the subcommittee meeting. Ms. Rashidchi responded that this will be agendized at the next subcommittee meeting. Mr. Thurmond commented that he will address the Youth Commission under the Safety Committee report.

**Ivy League Connection**: Mr. Ramsey reported on an upcoming student orientation for chaperones to meet families and students, a series of meetings with mentors and expansion of a collaborative at Pinole Valley High School. He further reported on scholarships to provide summer instruction time for students to prepare for program admissions tests.

**Safety Committee:** Mr. Thurmond announced that the next meeting is planned for June 17, 6:00 p.m. at Pinole Valley High School where discussion will be held around safety protocols in schools and issues regarding police response efficiency. He reported that the Youth Commission planning meeting will be held June 15, 4:00 p.m. at RYSE Youth Center in Richmond. Mr. Ramsey asked about attendance and preliminary interest. Mr. Greer responded that approximately 20 youths and 4-5 adults attended the initial meeting with representation from most high schools. Ms. Miles asked whether the Youth Commission is under the umbrella of the Safety Committee and suggested adding it as an additional committee report in the future.

Mr. Thurmond thanked CBOC members for bringing up the concern and suggesting use of bond funds to continue the publication.

Mr. Medrano explained that he has not attended recent CBOC meetings due to conflicts with Board meetings.

Ms. Miles encouraged expressing the difference between bond funds and general fund monies to the public.

Mr. Thurmond suggested that the Citizen's Budget Advisory Committee is a venue to address finding savings and looking for other revenue in a timely meeting.

He said his organization has questions of the protocols for agencies called to protect children. He expressed concerns regarding police security on campuses, agreements between the district and city agencies, and procedures for law enforcement in the educational environment.

Mr. Thurmond asked whether the NAACP had been in touch with parent organizations at Portola and reported that he has heard parents talk about wanting to make Portola a safe campus. Mr. Nelson responded affirmatively.

Ms. Kronenberg said she is a believer in Challenge Day projects for middle schools as well as Anti-Defamation League training.

Mr. Medrano said he is in support of any program that encourages communication.

Ms. Miles spoke about a healing process in communities when acts of violence occur.

She indicated that Education Code §44955.5 provides for the adoption of a schedule for the notice and hearing process for affected employees, and adoption of this proposed schedule will allow staff to bring forward a resolution to reduce particular kinds of services at the June 24, 2009 Board meeting.

#### **Board Comment:**

Ms. Miles asked for further clarification for this resolution. Ms. Romeo explained that this resolution would only establish timelines in the event that additional certificated layoffs were required. She said that without adopting this resolution, the Board would be prevented from moving forward with an August layoff.

Ms. Kronenberg asked for clarification regarding the timeline. Ms. Romeo detailed recommendations from the Office of Administrative Hearings to insure that decisions can be made in a timely manner.

Mr. Ramsey said this resolution will give flexibility to address potential budget short falls and cautioned against handicapping the district.

Mr. Medrano asked about the number of positions considered for layoffs. Ms. Romeo said that number is dependent on other actions taken by the State of California and the Board.

Ms. Miles asked questions about July funding expectations. Ms. Gamba responded regarding cash flow deferrals for 2008-09 and State withholding of July funds, retroactive deficit cuts from future apportionments, and further potential deferrals. The district will be required to restructure cash flow projections for the entire next year to determine what that will look like. Ms. Gamba said that preliminary information from the State predicts larger deficits for 2009-10.

Mr. Thurmond asked about the amount of anticipated savings with potential layoffs. Ms. Gamba discussed class size reduction possibilities and other negotiable items. Ms. Romeo was asked for clarification to statements regarding the establishment of dates for layoff hearings and the timeline of June 25th for layoff notices. Ms. Romeo discussed the layoff process and the Education Code recommendation as well as a timeline for staff to determine and process layoffs. Ms. Gamba provided further input regarding Education Code guidelines for the layoff period. Mr. Thurmond asked for understanding of how the district can be effective from an educational standpoint. Superintendent Harter agreed and responded that additional cuts are not in the best interest of children but in trying to keep the district fiscally sound without further State intervention.

Mr. Medrano asked about salaries and benefits of outside police officers hired by the district. Mr. Medrano spoke about cuts to the contracted police, returning campus police and wondered if that might save teachers. Ms. Gamba said she would have to provide that information at a later time. Ms. Medrano continued to discuss sharing cuts across all sections of employees.

Mr. Ramsey said he thinks that Board Member Medrano makes good points; however, the community has said they wanted SRO's on campus. He continued by saying that the State is telling communities that funding must come from local sources. He said he supports the approval of this resolution to allow the Board some flexibility.

Ms. Miles, while supporting this resolution for budgetary purposes, said she agreed with Mr. Medrano to look at all areas for additional cuts to avoid cuts to the classroom.

MOTION: Mr. Ramsey moved approval of Resolution No. 95-0809: Adoption of Notice and Hearing Schedule Pursuant to Education Code §44955.5. Ms. Kronenberg seconded. Staff is seeking ratification of Change Orders on the following current District construction project: Kennedy High School Painting. Change Orders are fully executed by the District upon signature by the Superintendent's designee. Board ratification is the final step required under state law in order to complete payment and contract adjustment.

In addition to normal ratification, approval of the noted Change Order for the Mira Vista Elementary Sitework project is required by the Board, with special findings as noted below, because this is in excess of the Public Contract Code limit of 10% of the original contract value. In accordance with Public Contract Code 20118.4, the Board, by approving and ratifying these Change Orders, finds that it would have been futile to publicly bid the work in question because of the tight time frames to complete this work without affecting the operations of the District, and that the public is best served by having this work completed by the contractor on the project.

In addition to the Construction Change Orders, this action includes four Changes Orders to the modular building contracts at: Ford Elementary School Temporary Campus; Leadership Public Schools Temporary Campus; Richmond College Prep Modular Campus; and DeAnza High School Temporary Campus. #### **Background Information:**

At its meeting on June 3, 2009, the Board approved Coronado Elementary School to proceed to the Programming and Master Planning phase of work for renovation or reconstruction. The Board also directed staff to initiate an architect selection process immediately to ensure timely action on initiating the planning process at the site. Pursuant to the Board's direction, staff has initiated a selection process with the Coronado Site Committee. Three architectural firms were selected by staff for interviews at the school. The firms are all currently in the prequalified architect pool designated by the Board in 2006 for Measure J projects. Interviews were conducted on June 10, 2009 with the Coronado Site Committee. The recommended firm is WLC Architects.

Staff met with WLC Architects, at which time WLC provided proposed fees for Programming and Master Planning. The Architects anticipate a process which will look at a number of options for the Coronado site to allow the District flexibility for a range of budgets which may be available. The options to be reviewed will include full renovation of the existing buildings plus limited new construction to meet program requirements. As a part of this approach, the Architects will provide a prioritized menu of renovations for the District-in case limited funds are available. The team will also review options for full reconstruction of the site. It is anticipated that the work can begin over the summer with facilities assessments and background work. Intensive work with the Site Committee and community outreach is a part of the process and will be scheduled for the beginning of the next school year. It is anticipated that a Master Plan can be brought to the Board in late fall 2009.

The final step in completing the full renovation of Verde Elementary School is to upgrade the playground and complete sitework that was not finished during the main project in 2004. The scope of work includes playground asphalt repairs, play structure upgrades, new games and striping. The project also has a major site safety component with the installation of new perimeter fences and gates—including ornamental ironwork gates at the bridge entry to campus. The project also includes the installation of a new parking area adjacent to the administration building and associated security lighting, drainage and fencing.

Powell and Partners Architects prepared plans and specifications for the Verde project. The District conducted a public bid of the project. Bids were opened on June 2, 2009. Seven Contractors submitted bids. They are as follows: WR Forde \$949,000; Blossom Valley \$912,418; Bruce Carone Paving \$832,274; A&E Emaar \$825,000; Evans Brothers \$795,799; Bay Cities Paving and Grading \$726,000; and ERA Construction \$525,562. After the bid, and within the timeframe identified in the specifications, ERA Construction notified the District that there was a mathematical error in the calculation of its bid. #### **Background Information:**

A major element of the School Consolidation process is moving teachers, staff, and school contents from the three schools being closed to newly assigned sites. These are complex moves, with each of the closed sites sending teachers, staff, and contents to a number of different locations. The District's School Consolidation Team prepared bid documents which would give the District flexibility in the moves by circulating request for proposals based upon costs for unit prices to move a closing sites' contents to any location within the District. For example, the proposals request each firm to provide costs for: a four-person crew + supervisor for 8 hours; a standard mid-sized moving truck + fuel for 8 hours; and costs for boxes and labels.

Proposals from the moving companies were received on June 9, 2009. Seven moving companies submitted proposals. When ranked on the basis of total cost of Crew + Truck, the proposals are as follows: Mayflower \$2,470; Cor-o-van \$1,596; Doubleday \$1,577; Valley Relocation & Storage \$1,532; Chipman \$1,520; Crossroads \$1,486; and, Moving Solutions \$1,168. The lowest unit price mover is Moving Solutions at \$1,168 per day for Crew and Truck.

The total number of moving days is not known exactly, however, it is anticipated that there may be up to 40 total moving days needed under this contract. That would result in a total cost of just under \$50,000 for the base contract. Additional time may be needed depending up moving complexities at the sites.

On September 25, 2008, President Bush signed into law the American with Disabilities Amendments Act of 2008, which became effective on January 1, 2009. The act expanded the scope of disabilities covered under the Americans with Disabilities Act ("ADA") and Section 504 of the Rehabilitation Act of 1973 ("Section 504") as well as the protections available to students.

There are three key provisions of the Act that impact school districts as educators in terms of their responsibilities under the ADA and Section 504: (1) the definition of "disability" is expanded; (2) "major life activities" are clarified and expanded, and (3) most mitigation measures may no longer be considered in disability determinations.

Due to this the district's Section 504 policies, procedures, training materials, manual and forms had to be revised.

# <u>WEST CONTRA COSTA UNIFIED SCHOOL DISTRICT</u> <u>An Overview of Section 504</u>

Section 504 of the Rehabilitation Act of 1973 ("Section 504") is Congress' directive to schools receiving any federal funding to eliminate discrimination based on disability from all aspects of school operation. It states, "No otherwise qualified individual with a disability..., shall, solely by reason of her or his disability, be excluded from the participation in, be denied the benefits of, or be subjected to discrimination under any program or activity receiving Federal financial assistance..." Because the West Contra Costa Unified School District is a recipient of federal funding, it is required to provide eligible disabled students with equal access (both physical and academic) to services, programs, and activities by its schools.

Section 504 is a civil rights statute and not a special education statute. At each school, the responsibility for ensuring Section 504 compliance rests with the District, the school's Section 504 Site Chairperson and the principal or assistant principal.

There are two main purposes to Section 504. The first purpose of Section 504 is to protect students from discrimination under federal law. Section 504 assures access to educational services and the learning process that is equal to that given to students who do not have disabilities. All students who have a physical or mental impairment which substantially limits one or more major life activities, have a record of such an impairment, or are regarded as having such an impairment, are protected from discrimination under Section 504.

The second purpose of Section 504 is to provide a free appropriate public education ("FAPE") to those students who (1) actually have a physical or mental impairment, (2) that substantially limits, (3) one or more major life activities. The provision of FAPE is accomplished through the creation and implementation of Section 504 Service Plan. Only those students who satisfy all three of these criteria are eligible for, and are provided, regular or special education and related aids and services under Section 504 (in the form of a Section 504 Service Plan).

The American with Disabilities Amendments Act of 2008 made the following changes to the Act:

#### **Definition of "Disability"**

The original ADA and Section 504 define a "disability" as "a physical or mental impairment that substantially limits one or more major life activities ... a record of such impairment, or being regarded as having such an impairment." Although the actual language of the definition remains the same, the Act expanded the meaning of "disability" to create a broader scope of protection for individuals. Specifically, the Act rejects the U.S. Supreme Court's narrow construction of the definition and finds the Equal Employment Opportunity Commission's ("EEOC") ADA regulations, which interpreted "substantially limits" to mean "significantly restricts," to have created "too high a standard."

The Act broadens the meaning of "substantially limits" by explaining that an impairment that substantially limits one major life activity does not have to also limit other major life activities. In addition, even an impairment that is episodic or in remission (e.g. cancer) can meet the "disability" requirement if it substantially limits a major life activity when it is active.

Also, the Act expands the meaning of the term "regarded as" by establishing that an impairment does not have to limit or be perceived to limit a major life activity for an individual to be "regarded as" disabled. For example, an individual's contagiousness resulting from tuberculosis may not substantially limit his or her major life activities. Nevertheless, the individual may be "regarded as" disabled due to the negative reactions of other co-workers to the impairment. The law continues to emphasize, however, that a school district is only required to provide reasonable accommodations to individuals who are actually disabled, not when they are only "regarded as" disabled. Furthermore, the amended "regarded as" standard does not apply to minor or transitory impairments which last six months or less.

#### **Major Life Activities**

It was the regulations, not the actual ADA and Section 504 statutes, that listed the following major life activities: caring for oneself, performing manual tasks, walking, seeing, hearing, speaking, breathing, learning, and working. Now, the Act expressly includes this non-exhaustive list of major life activities a school district must consider when making a disability determination. The Act also adds the major life activities of eating, sleeping, standing, lifting, bending, reading, concentrating, thinking, and communicating to the list. Furthermore, the term also includes major bodily functions such as functions of the immune system, normal cell growth, and digestive, bowel, bladder, neurological, brain, respiratory, circulatory, endocrine, and reproductive functions.

#### **Mitigating Measures**

The ADA and Section 504 are silent on the use of mitigating measures to deny an individual's legibility for coverage. However, the U.S. Supreme court interpreted the ADA and Section 504 to allow mitigation measures, such as medication, hearing aides and the use of assistive technology, to be considered in making a disability determination. Now, the Act instructs that school districts can no longer consider mitigation measures to determine whether an impairment substantially limits a major life activity, except for the use of ordinary eyeglasses or contact lenses.

#### **IDENTIFICATION AND EDUCATION UNDER SECTION 504**

#### **Identification, Evaluation And Placement**

The Governing Board of Trustees recognizes the need to identify and evaluate students with disabilities in order to provide them with a free appropriate public education ("FAPE"). Students found eligible uUnder Section 504 of the Rehabilitation Act of 1973 ("Section 504") individuals with a physical or mental impairment that substantially limits one or more major life activities are eligible to receive, may require regular or special education and related aids and services that are designed to meet the needs of disabled students as adequately as the needs of non-disabled students are met, and are based upon the District's procedures that satisfy Section 504 requirements. In addition to providing a FAPE to students with disabilities under Section 504, the District will not discriminate against students with a physical or mental impairment which substantially limits one or more major life activities, have a record of such an impairment, or those being regarded as having an impairment. Protections for these students are provided for elsewhere under District Board Policies and Regulations, state and federal law.

The Superintendent or designee shall establish and implement: screening and evaluation procedures to be used whenever there is reason to believe that a student has a disability that substantially limits learning or another major life activity. because of a disability, needs or is believed to need special instruction or related services; a system of procedural safeguards that includes notice, an opportunity for the parent/guardian of the student to examine relevant records, an impartial hearing with the opportunity for participation by the student's parent/guardian and representation by counsel, and a review procedure.

A Section 504 Team composed of knowledgeable professionals shall meet to determine the student's eligibility under Section 504, and the student's parents shall be invited to participate. The evaluation may include, but is not limited to, classroom observation, performance-based testing, academic assessment information, and data offered by the parents.

An evaluation shall be conducted to determine whether a student is eligible under Section 504. The evaluation may include, but is not limited to, classroom observations, testing, teacher and parent/guardian input, existing reports and District evaluations. A Section 504 Service Plan team composed of knowledgeable professionals shall meet to consider the evaluation results and to determine the student's eligibility under Section 504. The student's parent/guardian shall be invited to participate in this meeting.

If the student is found to have a disability that qualifies him/her for **a FAPE** accommodations and services under Section 504, **then** the Section 504 Team members

shall develop a written Section 504 Service Plan for the each student. Upon reviewing the nature of the disability and how it affects the student's education, the members shall determine what regular modifications and/or special education related services and aids and services, accommodations and/or modifications are needed in order to provide ensure that the student receives with a FAPE. The student shall be educated with non-disabled students to the maximum extent appropriate. to the student's individual needs.

The Section 504 Service Plan **Tteam** shall provide the parent/guardian with a copy of the Section 504 Service Plan. If the Section 504 Team determines that the student is not eligible for services under Section 504 or that no modification of educational services is needed, the parents/guardian shall receive a copy of the Section 504 Service Plan team meeting notes stating the basis for this decision. record of the proceeding stating the basis for this decision. Parents/guardian shall also receive a copy of the procedural safeguards guaranteed under Section 504. 34 CFR 104.36.

#### **Background Information:**

The District accumulates vast amounts of operational and educational data that is stored in separate "information silos." District data sources include, but are not limited to: PowerSchool (replaces SASI) Student Information System, Encore (SPED), Edusoft, STAR, State Test Results, CAHSEE, SAT, Advanced Placement, Follett, Blackboard Connect Ed, Food Services (Winsnap), English Learner Services, Bi-Tech and SchoolDude. Business and operational information systems, like Bi-Tech and SchoolDude, do provide the information (data) needed to run the day-to-day operations of the District; but what is needed is for all these different kinds of information to be readily available and integrated at one location to make strategic decisions. Sometimes a particular department (ITS, Finance, SPED, Assessment, Educational Services) or school can produce ad hoc reports from a single application. But in most cases, the reports need data from multiple systems, requiring the writing of extract programs to create intermediary files that could be used to produce the ad hoc reports. This process is very labor intensive, requiring specialized technological skills.

Implementation of the District Data Warehouse System and Services will provide the data needed for strategic decision making and is available in an interactive manner. District employees will be able to query online and get results. The information will be in a format suitable for analysis. The data warehouse is a simple concept involving different functions: data extraction, data loading, transforming the data, storing the data, and providing easy-to-use (and friendly) user interface.

This project also follows a key recommendation from the NCEA (National Center for Educational Accountability) report.

#### **Background Information:**

On February 11, 2009, the Board approved a school closure plan that included moving the Adult Education operations into a single facility at Kennedy High school for the 2010-11 school year. A few days later the California Legislature adopted a 2009-10 budget that essentially eliminated categorical funding for a host of programs including Adult Education. On April 1, 2009, the WCCUSD Board approved transfer of categorical funds from the "Tier III" programs including Adult Education to the general fund of the district.

In order to reduce overhead expenses and put the maximum available resources into programs for the adult population, district staff made plans to consolidate the administrative functions of the Adult Education facilities into a single site at Alvarado. Staff conducted a comparison of the two sites on four dimensions: space availability, access to public transportation, expenditures for site improvements and security. In each dimension, Alvarado was found to be more suitable than the Serra site.

Since Adult School programs are offered at schools, senior centers and community centers, the classes that have been at Serra and that will remain after the program reductions will be offered at other facilities in the central part of the school district including Mira Vista, Riverside, Ford, Grant and Wilson Elementary schools and Helms Middle school as well as in other community centers and other facilities.

#### **Recommendation:**

That the Board approve the closure of the Serra facility

# Adult Education – Proposed Location for 2009-2010 Alvarado Campus, 5625 Sutter Avenue, Richmond

# **Rationale for Site Selection**

In comparing the Serra site to the Alvarado campus, the major differences are *space, access to public transportation, the monies previously allocated for program/site improvement, and campus security.* 

# **Space Availability:**

- 1. The Alvarado campus will accommodate a reduced program while still allowing for expansion in anticipation of future growth in subsequent years.
- 2. The Alvarado campus is larger than the Serra Campus, thus providing sufficient classroom availability for mandated/core programs and community fee-based classes.
- 3. The Alvarado campus offers two additional classrooms versus the Serra site.
- 4. Due to more available space, additional portables can be added to the Alvarado campus.
- 5. The Alvarado campus offers generous on-site and secure parking availability as opposed to Serra.
- 6. The Alvarado Multi-Purpose Room is much larger than the MPR at Serra (this includes the stage area).
- 7. The proposed new Main Office at Alvarado will be much larger than the current Main Office at Serra.
- 8. The existing ESL Office at Alvarado will be moved to a new location that will provide more storage capabilities and a restroom, as opposed to the current configuration.
- 9. The Alvarado campus provides more storage room for materials, equipment, and archival records.

# Access to Public Transportation:

- 1. Public transportation is more accessible to arrive directly to the Alvarado campus, than current public services that directly reach the Serra site.
- 2. The main bus line is closer, and the bus routes are more frequent to the Alvarado campus than the Serra campus.
- 3. Alvarado has easy access to BART.
- 4. Alvarado is accessible to the BART Bike Trail.

# **Expenditures for Site/Program Improvements:**

- 1. During the Fall of this year, new carpeting was installed in Room 16 at Alvarado.
- 2. This year, approximately *\$70,000.00* was spent installing a new boiler/heating system (this figure includes *\$15,000.00* for asbestos abatement).
- 3. During the 2007-08 school year, significant expenditures were made for electrical upgrades at Alvarado.
- 4. During 2007-08, a Parent Education Office was established in Room 9 at Alvarado, which also required electrical upgrades.
- 5. At Alvarado during the 2007-08 school year, a "teaching kitchen" was created at a cost of *\$30,000.00* to support one of our more popular fee-based programs.
- 6. Last year, high speed Gigaman internet connectivity was installed at Alvarado.
- 7. During the 2003 school year, at a cost of *\$8,000.00*, a wheelchair lift was installed at one entrance to the Multi-Purpose Room at Alvarado.

In 2001, the Adult School spent *\$800,000.00* to open the Alvarado campus:

- 1. New roof
- 2. Replaced all lighting fixtures
- 3. New alarm system
- 4. Painting interior/exterior
- 5. Security bars on windows
- 6. Window and window covering upgrades
- 7. Carpet installed offices and classrooms
- 8. Slurried the entire parking lots
- 9. All new entry doors
- 10. Conversion of restrooms to accommodate ADA mandate

# **Campus Security:**

By virtue of its configuration, the majority of the Alvarado classrooms are self-contained within the building, as opposed to the open/outdoor ambience that Serra features. Due to the layout, the Alvarado campus is much easier to supervise and is generally considered secure and safe.

Given the sharp decline in resources for current initiatives, will the Board add new initiatives without eliminating previous ones?
