## **TIP PROCEDURES**

| PT/SP Match                             | A PT or SP is<br>dissatisfied with their<br>current match   | <ul> <li>The PT of SP contacts TIP stail who meet with each partner individually and/or together to assess the situation, problem-solve and identify possible solutions</li> <li>If mutually agreed, PT/SP work to improve relationship</li> <li>If one or both partners continue to be dissatisfied, TIP staff suggests a new match.</li> </ul>   |
| Requesting<br>Your Records              | A PT needs a copy of his/her induction records (Letter of Completion, Letter of Program Status, Requirements and Progress Check)            | <ul> <li>The PT makes a written request (email) to TIP staff and/or submits the TIP Inquiry/Request Form for the specific document.</li> <li>TIP staff will provide a hard copy of the requested document to the PT and/or send the requested document electronically to the necessary third party.</li> </ul>   |
| Repeating<br>Portions of<br>the Program | A PT needs to repeat portions of the program and/or is not able to complete portions in one and/or two years                                | <ul> <li>The PT and TIP staff will meet and discuss portions of the program that need to be repeated and/or completed.</li> <li>TIP staff will develop a Completion Plan for the PT.</li> <li>TIP staff will share the Completion Plan with the PT and the PT's SP. All parties will sign the Completion Plan.</li> </ul>  |
| Grievance<br>Process                    | A PT wants to grieve actions and decisions related to admission, progress, and/or completion of their program                               | <ul> <li>The PT shall first discuss the grievance with the appropriate TIP staff member(s), with the objective of resolving the matter informally.</li> <li>If the matter is not resolved informally, the PT may submit a written grievance via email with Dr. Janet Scott, Director of Human Resources. The PT, Dr. Scott, and/or TIP staff member(s) will work together to resolve the matter.</li> </ul>  |
| Program<br>Closure                      | • The WCCUSD TIP Program closes*  *Note: WCCUSD does not anticipate the closing of its Teacher Induction Program in the foreseeable future. | <ul> <li>There is a Teach Out Plan. Enrolled PTs in WCCUSD TIP will be provided with an individual transition plan:         <ul> <li>TIP staff will work with each PT to find a Commission-approved program.</li> <li>TIP staff will provide each PT with the necessary documentation that shows their induction progress and allows them to continue induction with another program.</li> </ul> </li> <li>*Click here for the full Teach Out Plan.</li> </ul> |
