First Round of Focus Group Meetings

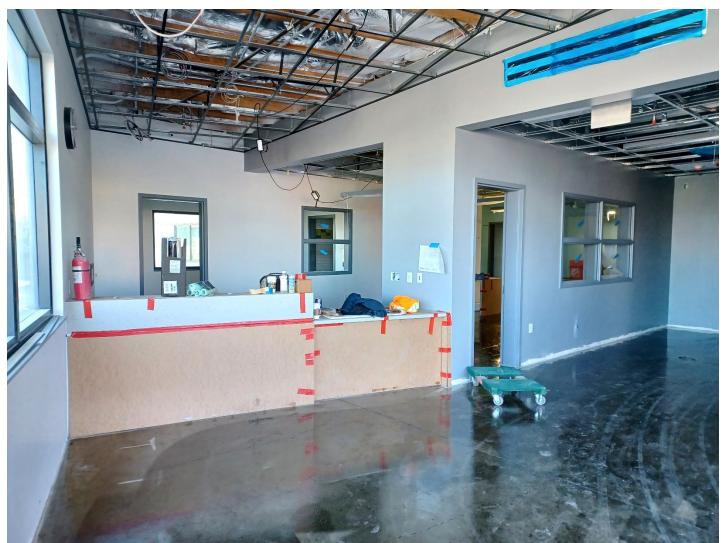

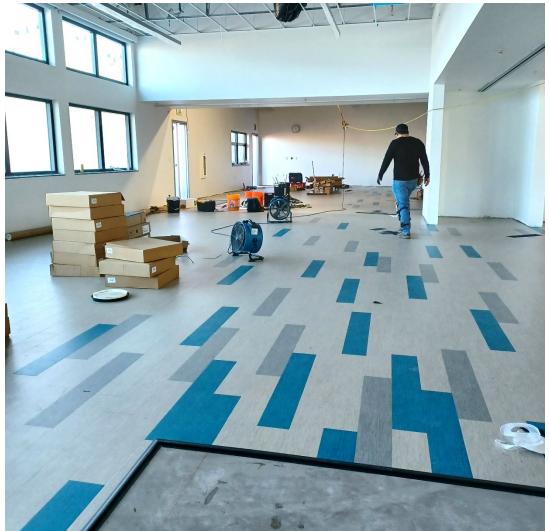

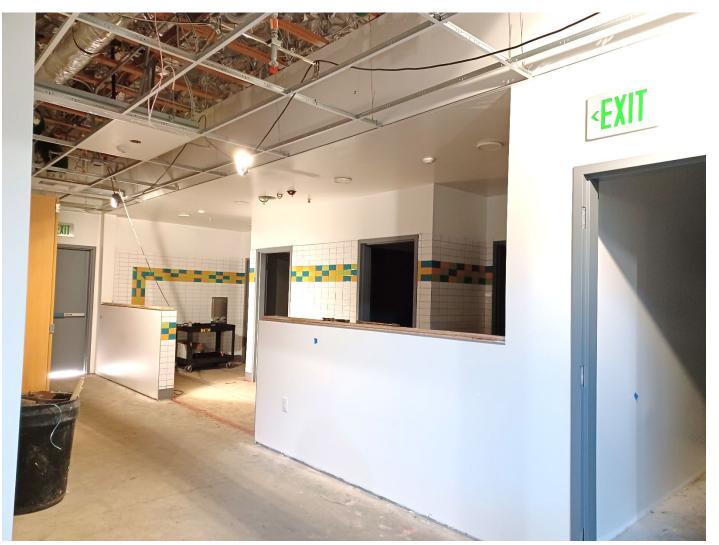

Project design started in August 2021 and the first phase of construction is scheduled to start in Summer 2022. Construction for Phase 1 is scheduled through Summer of 2023 and Phase 2 is scheduled through Fall 2025. This project is an investment in our community through the use of taxpayer bond dollars.

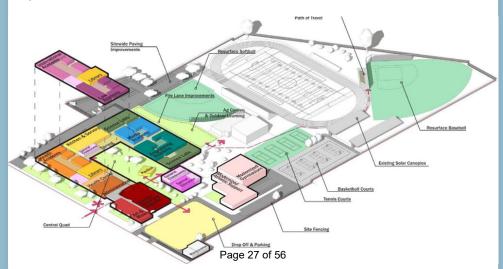

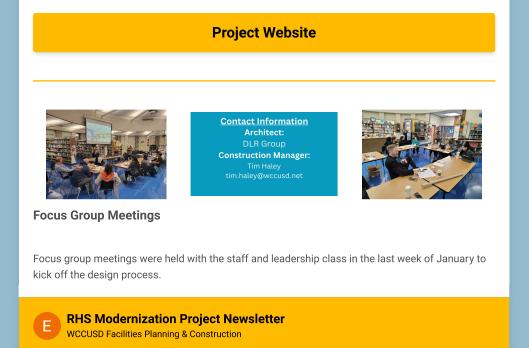

#### Timeline for CBOC Issue on Non-Compliance to Proposition 39 at West Contra Costa Unified School District

July 10, 2023 – Chairperson Humes presented report on Non- Compliance to Proposition 39 at CBOC meeting – members voted to send report to several public organizations - CoCoTax was one of them.

August 2023 brainstormed matter with Jim Pezzaglia, Vice President of CoCoTax

September 18, 2023 Sent report to Superintendent Hurst and BOE asking for meeting

October 27, 2023 – At CoCoTax meeting asked for help in this matter

November 13, 2023 Jack Weir, CoCoTax Director, attended our CBOC meeting bringing a draft of a letter from Co Co Tax

December 20, 2023 - sent final revision of letter to Superintendent Hurst and BOE

January 30, 2024 – Superintendent Hurst scheduled a zoom meeting to discuss this matter with CBOB, BOE, and CoCoTax representative Jack Weir.

#### **FAI Implementation Reviews**

On September 21, 2016, the Board of Education approved the final report of the "Forensic Accounting Investigation" by Vicenti, Lloyd & Stutzman, LLP (VLS). The investigation was to review complaints, made by a 'whistle blower' and assess the risk of fraud, corruption and waste in the bond program. In addition to assigning risk factors to 62 aaligations, the VLS investigations had 112 recommendations to reduce risk related to the allegations and improve organizational efficiency.

The Board of Education approved the formation of an Implementation Task Force (ITF) on September 21, 2016. It was estimated that the implementation and audit process would be completed in 2018.

Moss Adams LLC. completed a review of 62 recommendations, identified by the District as fully implemented, on June 30, 2017. (33 implemented, 19 partially implemented, 3 not implemented, and 7 undetermined\*). This is called Phase 1 of the review.

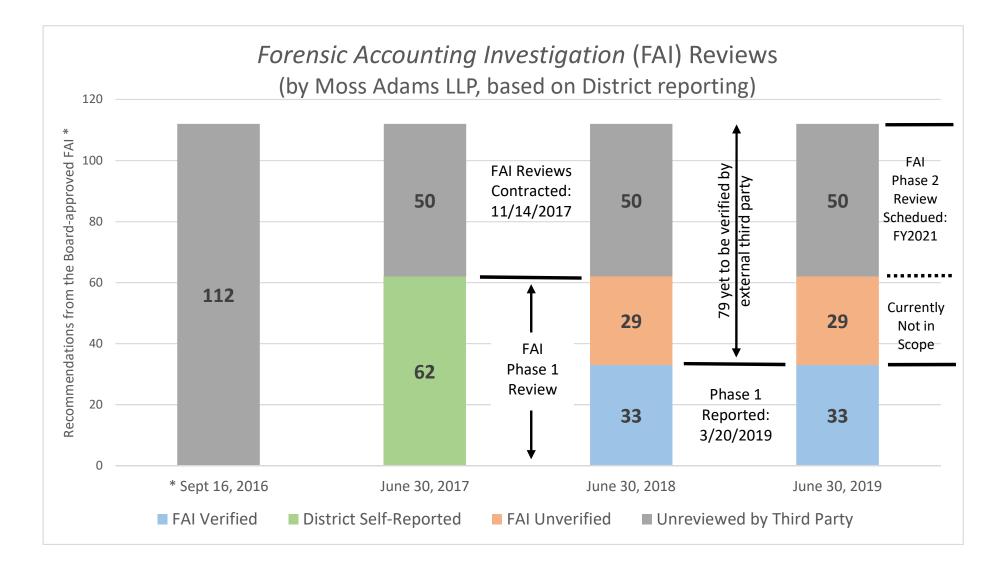
Eide Bailly was awarded a contract to complete Phase 1.5 of the review. Phase 1.5 was to review and verify the 29 recommendations not deemed implemented in Phase 1. The anticipated completion date for this review was 5/17/2021. (See FY 2020 Audit Schedules Chart in the CBOC 3/8/21Agenda Packet)

Moss Adams LLC. was awarded a contract to complete Phase 2 of the review. Phase 2 was to review and verify the remaining 50 recommendations implemented after June 30, 2017. The anticipated completion date was 5/17/2021. (See FY 2020 Audit Schedules Chart in the CBOC 3/8/21 Agenda Packet)

In a report presented entitled, *Aligning Bond Audits to our Practice, Part Two,* to the CBOC, at our 5/9/2022 meeting, the completion dates for Phase 1.5 and 2.0 of the reviews was pushed back to the Summer of 2022

#### Status:

As of January 2024 we have not received the status update on a review of the complete implementation of the FAI recommendations, approximately six and a half years after Moss Adams gave their report on their Phase 1 of the review.



#### **Financial Monthly Reports for Construction Bond Program**

The District would give the CBOC a financial packet of seven to eight reports each month. They also posted the reports on the Facilities, Planning and Construction Department webpage. From February 2022 through January 2024 we have either not received these financial reports or received them two to nine months late. (Note there are no reports in the archives of District's database of bond program financial reports for 2023.)

- Two members residing in unincorporated areas of the district recommended respectively by the two county supervisors who have districts that overlap with WCCUSD
- Five members recommended respectively by each member of the Board of Education
- One member representing the Contra Costa Building and Construction Trades Council
- One member of Public Employees Union Local 1 (who is not a district employee)"

I assume after the Grand Jury's findings, the District went back to two to five special category members and four at-large members.

### ANTON JUNGHERR January 5, 1933 ~ December 18, 2023



Anton Jungherr, age 90, peacefully passed away on Monday, December 18, 2023, surrounded by loved ones and in the comfort of his home in Hercules, CA.

Anton was an amazing man of action who worked tirelessly, served humbly, and gave generously to make tomorrow brighter than today. While Anton ultimately succumbed to stomach cancer, he lived a full and powerful life and remained active, sharp, and dedicated until the very end.

He was born in New Haven, CT and grew up in Storrs, CT on the University of Connecticut campus where his father, Dr.

Erwin Jungherr, was a professor and the Head of the Department of Pathobiology and Veterinary Science from 1930 to 1959. His mother, Marie Healy Jungherr, was a homemaker.

Anton graduated from the University of Connecticut with a Bachelor of Science in Business Administration (1954), Syracuse University with a Masters in Public Administration (1958), and Teachers College, Columbia University, with a Masters in Education (1971). He was the co-author, with Robert Alioto, of a textbook on school budgeting published by Harper & Row, New York, 1971. He was a lifelong learner, attending many conferences, workshops, and classes.

Anton had a varied career defined by service: U.S. Army First Lieutenant, Adjutant General's Corps; General Electric Company Business Management Trainee; Assistant City Manager/City Clerk in Lake Forest, IL; Controller for the Anchorage Public School District (AK); Assistant Superintendent for the Pearl River School District (NY); Director of Finances for the City of Newark (NJ); Deputy Superintendent for the Yonkers School District (NY); Deputy Superintendent for the San Francisco Unified School District (CA); Owner tax/accounting practice in San Francisco (CA); Associate Superintendent for the Berkeley Unified School District (CA); Business Manager/Chief Financial Officer

for the Making Waves Education Program/Making Waves Academy, Richmond, CA.

During his career, Anton was a fighter for change who never shied away from challenges or feared the unknown: He went to Alaska two years after they became the 50th State, driving his Volkswagen Camper from Illinois to Alaska. He went to Newark, NJ after the 1967 Newark Riots; four days of rioting, looting, and destruction that left 26 dead and hundreds injured. He went to the San Francisco Unified School District after the State Superintendent of Schools made a public statement that San Francisco schools were an "embarrassment" to him. He went to Berkeley Unified School District after they had gone into bankruptcy.

Over the last 48 years in California, Anton has impacted many communities, organizations, and lives. He started his own accounting and tax company with one client, holding meetings at his kitchen table, and grew his business to over 500 clients before he sold it and returned to work in the public sector, at the Berkeley Unified School District, in 1988. After a life of adventure, Anton planted roots in Hercules in 1999 and made it his home. In 2001, Anton was a member of the founding team for Making Waves Academy, a public charter school in Richmond, CA.

Anton was a co-founder of the California League of Bond Oversight Committees (2006-2018) to promote school district accountability by improving the training and resources available to California Prop 39 school board oversight committees, educating the state legislature, local school boards, and the public.

In June 2011, Anton led the movement to reform the Hercules City Council, resulting in the resignation of the Mayor, the recall of two Council members, and the election of three reform Council Members. He served on the City of Hercules Finance Commission.

In 2019, Anton co-founded the California Association of Bond Oversight Committees, a nonprofit California Public Benefits Corporation, with Jack Weir. The Association's purpose was to provide training to over 4,000 Citizens' Bond Oversight Committee members in California on effective oversight of school bond construction projects.

In addition to his best friend and the love of his life, Lori Chinn, and Lori's daughter, Kari Chinn, and son, Adam Chinn, Anton is survived by three daughters, Karen Manning of Sharon, CT; Lisa Jungherr of Los Altos, CA; and Anna Mikuriya Jungherr of Alameda, CA, his son, Antonious Mikuriya of Brooklyn, NY, his sister Eileen Roehr of Reston, VA, brother Mark Jungherr of Williston, FL, and former wife Mary Jane Mikuriya of San Francisco, CA. Anton was predeceased by his twin sister Barbara Santacroce, brother Kent Jungherr, and former wife, Elizabeth Elwell.

Anton often recalled the Athenian Oath, during his many years of public service and volunteer activities, that graces the first floor of Maxwell Hall at Syracuse University: "We will transmit this city not only not less, but greater, better and more beautiful than it was transmitted to us."

Anton was immensely proud of his Boy Scout Eagle Award, received in 1948. Throughout his life, he tried to honor the Boy Scout Oath, especially duty to his country and to help other people at all times. He followed the Scout Law and the Scout motto, "Be Prepared."

Robert Baden-Powell, the founder of Scouting, taught Scout trailblazers to make a simple trail sign, a circle with a dot in the middle, to indicate that they had gone home. This Eagle Scout blazed many trails for us to follow, and now he too has gone home.

In keeping with his philosophy on promoting education and passing on learning, Anton donated his brain to the UCSF Brain Health Registry. In accordance with his wishes, a public service will not be held.
