The Selection Process

- 1. You email your application materials to Associate Superintendent Lisa LeBlanc and the CBOC Chair.
- 2. Ms. LeBlanc acknowledges your application.
- 3. Ms. LeBlanc schedules an interview for you with the Board of Education's Facilities Subcommittee if there is a vacancy in your membership category.
- 4. Ms. Leblanc tells you when to appear. You must appear in person.
- 5. Your application (with personal contact info redacted) is published in the packet for that meeting.
- 6. The Facilities Subcommittee interviews you.
- 7. The Facilities Subcommittee votes on whether to recommend you.
- 8. If you are recommended, a "consent item" is placed on an upcoming Board of Education agenda to actually appoint you.
- 9. You don't have to appear at this Board meeting.
- 10. Once you are appointed by the Board, your two-year term on CBOC starts.


