**Background:** The West Contra Costa Unified School District Redistricting Commission is tasked with creating trustee areas for the 2022 elections for the Board of Education. The commission, authorized by <u>California Elections Code sections 23000</u> - 23003, consists of seven members representing each of the five trustee areas and two members who are residents of Contra Costa County but live outside of the district boundaries. Commission members were selected by senior inactive US District Judge Thelton Henderson.
