# Public Comment & Announcements:

The CAC dates for the 2015/2016 school year have been confirmed and flyers were distributed to members.

## **SELPA Directors Report:**

Legislative Information Sharing Day (Leg. Day) had a very large turnout, with more CACs participating from across the state.

SELPAs were recognized for participation in Alternative Dispute Resolution, (ADR). Next year the ADR grant money will be shared by 8 SELPAs. WCCUSD will still use the ADR model without the grant funding.

Districts will know more after the Governor's May revise.

We will be audited by the state because our funding for mental health services has not been spent as quickly as when funding was handled by county and we have carry-over funds. The district will add 3 counseling enhanced classes for 2015/2016 and may add one at the transition age level.

The state has changed the review process. Instead of a verification review, they've switched to an annual application. WCCUSD will be expected to submit information in the coming year.

Classroom changes: 1 primary SH at Peres 1 NSH intermediate at Sheldon

We are adopting the Star curriculum which is ABA based; purchasing it for Pre-K and primary SH classes. These are comprehensive kits that give teachers all the materials they need.

The Budget Plan was presented to the CAC for review.

The Service and Budget Plans will be discussion items at the board meeting on June 10 and approval items on June 24.

#### **Old Business**

At Leg. Day – the One System: Reforming Education to Serve All Students - Executive Summary was shared with participants. It is a seven part recommendation plan developed by a task force made up of community stake holders.
