Recording Discipline in Incident Management

Note: Incident Management is the only reporting method for students who commit a behavior contained in Ed Code 48900 & 48915 ("suspendable" offense).

Federal reporting requirements have been modified to be based on "incidents". Each incident may have multiple students involved, and each student may commit multiple offenses during a single incident.

To fulfill local, state, and federal reporting requirements, all incidents where a Special Education student commits a behavior contained in Ed Code 48900 & 48915 have to be entered into PowerSchool Incident Management regardless of the consequence or duration of the suspension. This includes incidents that result in Restorative Justice. Non-Special Education students who commit a behavior contained in Ed Code 48900 & 48915 only need to be entered into Incident Management if the consequence is a suspension. Incidents should be entered by school site staff within a week of the occurrence. The following are important guidelines:

- 1. Students in grades KG to 3 should not be suspended for:
 - a. Sexual Harassment (code 403)
 - b. Hate Violence (505)
 - c. Harassment or Intimidation (506)
 - d. Disruption, Defiance (code 511)
- 2. Any incident involving a firearm is to be reported regardless of the action.

Creating an Incident

I. Incident Description

- 1. Select the student and click on Incident > Create New Incident
- 2. Select CA State Reporting under Incident Type
- 3. Populate **Incident Date** based on when the incident occurred.
- 4. Populate the **Title** and enter a **Description**, which should be a summary of the incident
- 5. Populate **Prepared By** with the administrator who handled the incident
- 6. OPTIONAL: Location, Location Description, and Financial Impact

II. Incident Builder: Participants

- 1. Click the **Plus (+)** button next to Participants and add the Offender by entering the **Last Name** and click the **Search** button. For Behavior Codes 403, 506, and 513 add the Victim.
- 2. Select the student in the **Results** box, click the **Add** button, select the offender role from the **Select Roles** menu, and click the **Add Participants Attributes** button
- 3. Repeat steps 1 and 2 to add additional offenders and victims.
- 4. OPTIONAL: Add Reporter and Witness if applicable.

III. Incident Builder: Incident Elements

1. Adding a Behavior

- A. Click the **Plus (+)** button next to Incident Elements
- B. Choose **Add Behavior** and select the Behavior. If there is more than one behavior created, select the **Primary Behavior**¹ checkbox based on the suggested hierarchy of offenses (pg. 2-3).
- C. Drag the Behavior to the appropriate offender and repeat steps A and B to define each behavior.
- D. For Behavior Codes 506 and 513 (Harassment and Bullying):
 - a. Select one of the five Bullying or Harassment subcodes
 - b. If none of the five subcodes apply, then select "None of the Above"

2. Adding an Action

- A. Click the Plus (+) button next to Incident Elements and choose Add Action
- B. Populate Action Date Range (the first & last date of suspension), select "School Days" for the Duration Code, and populate the Assigned Duration and Actual Duration up to two decimal places (e.g. 1.5 or 2.75)
- C. If the action is Expulsion, then choose the **Action Change Code**
- D. For Special Education students, choose the Action Authority Code

- E. For Special Education students, choose the **Instructional Support Indicator** refers to whether or not the student received instructional support during a discipline action
- F. For Special Education students, choose the **Removal to Interim Alternative Setting²** code
- G. Click and drag the action to the appropriate behavior or offender. The action will no longer appear under Incident Elements. Create an Action for every offender.
- 3. Adding a Weapon (required for Offense Codes 100, 101, 103, 104, and 105)
 - A. Click the **Plus (+)** button next to Incident Elements
 - B. Choose Add Object form the pop-up menu
 - C. Choose Weapons from the Object Code pop-up menu
 - D. Choose the appropriate weapon and click Add Object
 - E. Click and drag the object to the appropriate offender to associate the two elements
- 4. Click **Submit Incident** to save the changes

IV. Editing an Incident

 Use the Change Reason text box to record the rationale for the changes being made and click on the Submit Incident button to save the edit.

Important Reminders

- 1. The Action and Behavior must be dragged to the Offender and appear under the Offender for the Action and Behavior to be associated with the Offender.
- 2. The "S" code for Suspensions and the "H" code for In-House Suspensions should be marked in Attendance.
- 3. A student who instigates an incident, but did not commit a behavior contained in Ed Code 48900 & 48915 should not be marked as an Offender.
