#### **CSBA Delegate – Bruce Harter**

WCCUSD is now eligible for a designated representation at the California School Boards Association (CSBA) delegate assembly. Ms. Kronenberg was elected by our region as one of the region's delegates. Our Board now has the opportunity to designate another WCCUSD Board member for CSBA's delegate assembly. Districts that have an average ADA of greater than 30,000 students are allowed a designated representative. Our enrollment which has been just below the threshold over the past several years rose above the cut-off level last year. The new appointment runs from April 1, 2016 through March 31, 2018. The Board has until March 15, 2016 to act on an appointment.

#### **Kindergarten Immunization Report – Steve Collins**

The Kindergarten Immunization report for 2015-2016 shows that out of a total of 2235 students, 2196 met the immunization requirements for Kindergarten, making us 98% compliance. There were 2 students who had Permanent Medical Exemption and 15 with Personal Belief Exemption. 22 students were still in need of follow up, 11 of them need Hepatitis B vaccination. We have 17 schools that are 100%, up from last year's 12 schools. Please see the attached Kindergarten Immunization Report.

# 7<sup>th</sup> Grade TDAP Report – Steve Collins

The 7<sup>th</sup> Grade Tdap (whooping cough) report of 2015-2016 shows that out of a total of 1880 students, 1870 met the immunization requirement to enter 7<sup>th</sup> grade, resulting in 99% compliance. There were 10 students who did not meet the requirement. There were 5 students with Permanent Medical Exemption and 5 students with Personal Belief Exemption. We have 5 schools that are 100%, unchanged from the previous school year. Please see the attached 7<sup>th</sup> Grade TDAP Report.

## Educator Effectiveness Professional Development Funding-Nia Rashidchi

California's SB-77 Section 58 provides new funding for professional learning for every district, county office of education, charter school, and state special school throughout the state. This funding source is referred to as *Educator Effectiveness* monies.

The state requires that these funds be spent in the following four ways:

- Beginning teacher and administrator support and mentoring, including, but not limited to, programs that support new teacher and administrator ability to teach or lead effectively and to meet induction requirements,
- Professional development, coaching, and support services for teachers who have been identified as needing improvement or additional support by local educational agencies,
- Professional development for teachers and administrators that is aligned to the state content standards, and
- To promote educator quality and effectiveness, including, but not limited to, training on mentoring and coaching certificated staff and training certificated staff to support effective teaching and learning.

WCCUSD will receive approximately \$2.3 million dollars to be spent over 3 years (2015-16, 2016-17, 2017-18).

Staff will share the plan to spend the funds at the November 18 board of education meeting. There will be a public hearing during the November 18 meeting, and then the plan will be brought back to the board for approval at the December 9 board of education meeting.

Several items in the plan focus on teacher induction and peer assistance and review support, targeted new teacher and administrative support, and professional development focused on the California Standards, integration of technology, growth mindset, illuminate training, and leadership.

There will also be a line item for a new on-line personalized learning platform called Edivate that we are really excited about. Below please find some helpful information that discusses our professional learning vision, as well as provides some answers to the What, How, Who, and Why questions. We have also included a 2-pager in this Friday memo that describes Edivate in more detail.

WCCUSD's Vision Statement for Professional Learning is as follows: WCCUSD will provide intentional, job-embedded adult professional and personalized learning for teachers, administrators, and other staff to enhance student learning. The design will meet learner's needs through a variety of innovative implementation models and materials. Tools will be available 24 hours/7 days a week.


