Lead Testing in District Schools – Lisa LeBlanc

The State Water Resources Control Board's Division of Drinking Water, in collaboration with the California Department of Education, has taken the initiative to provide resources for testing drinking water in schools (K-12) for lead. Through this initiative, our District's Maintenance and Operations Department in collaboration with East Bay Municipal Utility District, is scheduled to start Lead Testing during the week of October 23, 2017. The tests will take place at 2-3 schools per day in the early morning. A requirement for the test is for the water to sit still for 6 hours before testing. Testing is estimated to continue until December 2017.

Ombudsmen Update – Matt Duffy

The Office of the Ombudsperson is now fully operational. We have brought all of our complaint procedures to one room under the leadership and direction of Rhonda Haney. The Ombuds Office now handles all complaints - Williams, Uniform, Personnel and Title IX. The Ombuds Office directs staff on how to handle complaints, meet required timelines and performs investigations where needed. If parents are not satisfied with the district handled complaint process, they can appeal to the Ombudperson for review. The introduction to the office is now on our website. Follow up Williams Complaint- Wilson School – Ken Whittemore

On Wednesday October 18, 2017, the Board of Education inquired about a Williams Complaint that appeared on the Contra Costa County Office of Education Quarterly report to the District. Specifically, the report was made anonymously, and lodged a complaint about facility questions at Wilson Elementary School. The complaint outlined cleanliness and rodent issues.

The Maintenance and Operations Department responded, ensuring cleanliness and eradication of the problem (see attached letter dated June 23, 2017). There was no follow up complaint once these items were addressed.

RE: Wilson Elementary vermin evidence in classrooms

Dear Ms. Valdez,

The West Contra Costa Unified School District received a complaint submitted by you from an unidentified source on June 16th, 2017, under Education Code Section 35186; William Complaint Procedures (as contained in West Contra Costa School District Administrative Regulation 1312.4, Williams Complaint Procedures). Upon receipt of the complaint, the District was not aware of the condition described in the complaint. Specifically; Mice infestation.

• <u>Facility Conditions</u>: "Mice infestation mice droppings office, teacher lounge, copy room, cafeteria classrooms Infestation is getting worse droppings every where "

The Williams Uniform Complaint Procedure defines the conditions that poses an emergency, urgent or threat to the health or safety of students or staff including nonfunctioning; heating, ventilation, fire sprinklers, or air conditioning systems, gas leaks, electrical power failure; major sewer line stoppage; major pest or vermin infestation; broken windows, or exterior doors or gates that will not lock and that pose a security risk; abatement of hazardous materials previously undiscovered that pose an immediate threat to pupils or staff; or structural damage creating a hazardous or uninhabitable condition, and or other emergency.

The complaint was reviewed by District Administration in consultation with the Operations Department and Pest Control Contractor; Kelley Pest Control. The District conducted an inspection of conditions on June 16th, 2017. Evidence of mice presence was verified in the main office, room 1, 4, copy room. There was no evidence of vermin in the kitchen area.

The date of the inspection was conducted during summer recess and did not represent a school year with students or staff present. This is relevant because the evidence indicated that partial summer cleaning may have exposed mouse droppings that were not evident during the school year. Active vermin activity usually presents an aromatic, physical damage and fecal evidence. At the time of the inspection, the campus was a warm indoors which increases odors; however none was detected. No papers or cardboard shredding was evident in the areas inspected

although materials were present. Fecal evidence was present but appeared to be covered with a layer of dust that indicated that vermin presence was not recent.

The District contacted the Pest Control Contractor shared that Wilson Elementary was not considered an active vermin site. An inspection of the nontoxic sticky traps showed no evidence of vermin. Vermin traps are inspected by custodial staff and replaced annually in classrooms unless activity is detected. Kitchens traps are inspected by the pest control contractor and replaced every other month unless activity is detected. The District inspection identified potential vermin nesting materials by the waste containers and will eliminate the ivy growth around the containers to reduce any vermin activity associated with trash collection.

The District will continue to prepare Wilson Elementary School for the 2017/18 school year. The summer cleaning will identify any additional areas of concern and new nontoxic vermin traps will be installed throughout the campus. Custodial staff will monitor conditions and should there be any activity or evidence identified; the district contractor will be contacted to address the issue immediately.
