2017-18 Single Plan for Student Achievement (SPSA) on Board Agenda for November 15 – Nia Rashidchi

During the November 15 Board meeting, the **2017-18** Single Plans for Student Achievement will be on the agenda for approval.

We wanted to provide Board members with a little background on SPSAs, as well as our twoyear-long journey of getting our SPSA process and timeline aligned with our LCAP process and timeline.

EC Section 64001 specifies that schools and districts that receive state and federal or other applicable funding through the district's Consolidated Application process must prepare an SPSA for any recipient school. The SPSA is a blueprint to improve the academic performance of all students. SPSA specifics are also subject to review during a Federal Program Monitoring process.

Timeline: The 2017-18 SPSAs have been developed by site staff in conjunction with the established School Site Councils at each district school. The SPSA development process began in the Spring of 2017 with the allocation of LCFF and Title I funds to sites and the review of data to determine the efficacy of 2016-17 programs. School teams finalized their SPSAs during the Fall of 2017. Central office staff provided support and guidance throughout the SPSA development process.

The completed Board approved SPSAs will be the foundational document that identify the Theory of Action, program focus and specific plans for use of funds to improve student achievement for the 2017-18 school year. As such, the SPSAs for identified schools will be included in the Federal Program Monitoring (FPM) visit conducted by staff from The California Department of Ed (CDE) this month (November).

Last school year, we began to align the SPSA cycle to the timing of the WCCUSD LCAP development process. This has been a two-year process, culminating in the **2018-19** SPSAs being brought to board for approval on the same timeline as the LCAP (June 2018).
