Board Policy – Ken Whittemore

- 2) The program at Richmond High School was difficult at times for El Cerrito, and Kennedy students to attend. They felt the program removed them from their home school and they were uncomfortable in the new surroundings.
- 3) The location of the program in the back of the school was difficult to get to at times.

Williams Act - Status of Maintenance Repairs - Lisa LeBlanc

At the November Board of Education Meeting, the Williams Act report was provided along with the current status of maintenance repairs that resulted from the 2017-2018 facility inspections.

Staff reported that the repairs would be made by March 2018. At the start of March, we have completed 84% of the repairs needed with 16% left to complete. Some of the items are larger pavement or playground repairs, which will be completed through a public procurement process and planned for the upcoming Spring break and during the summer. WCCUSD Food Services Celebrates National School Breakfast Week March 5-9, 2018 - Lisa LeBlanc

Busy weekday mornings make it a challenge for families to find time for a healthy breakfast. However, US Department of Agriculture data show that more students are starting their day with a nutritious breakfast in their school cafeterias. To encourage more families to take advantage of the healthy choices available with school breakfast, West Contra Costa USD schools are recognizing National School Breakfast Week, which is March 5-9, 2018.

WCCUSD Students are encouraged to "Take the Challenge" next week with special breakfast menus, cafeteria events, and more. Students are challenged to create posters showing the importance of breakfast, new menu items and California-grown fruit will be showcased.

Four new school sites will be piloting the breakfast program during this week: Hanna Ranch, Valley View and Ohlone from March 5th through the 9th and Olinda from Tuesday March 6th through the 9th, all from 7:30 to 8:30 AM daily.

Please join us. Breakfasts are no charge to eligible students, \$1.50 for non-eligible students at elementary schools and \$1.75 at all secondary schools, adults can purchase a breakfast for \$2.50.

"National School Breakfast Week helps us educate parents and students about all the healthy and appealing choices we offer". WCCUSD serves over 8,000 breakfasts daily through the federally funded School Breakfast Program. Our school nutrition professionals in West Contra Costa prepare breakfast and lunches every day that meet federal nutrition standards – limiting fat, calories and sodium – and encourage students to choose from the fruits, vegetables and whole grains offered with school meals.

Another reason for WCCUSD to celebrate is their breakfast grant award. The Hunger Is Campaign, an initiative of the Albertsons Companies Foundation (representing our Albertsons and Safeway stores) and Entertainment Industry Foundation, awarded the California Summer Meal Coalition/Institute for Local Government to help school districts, including WCCUSD, to increase access to school breakfast programs. The project also aims to identify connections between school attendance and access to school breakfast programs. Students that are late or miss school are also missing out on the crucial nutrition provided by school breakfast. The Coalition has provided funds to support WCCUSD's innovative and dedicated efforts to ensure students start their day nourished and ready to learn.
