Bond Program Cash Projection – Report #13 as of February 28, 2018 – Lisa LeBlanc

Please find attached Report #13, the bond program cash projection report to 2021. The Adjusted Cash Balance includes cash from Fund 21 (Building Fund) and Fund 35 (County Schools Facilities Fund). The cash balance includes funding received from the State Building Program for the Helms seismic project (\$5,341,000), together with receivables and payables.

Revenues of projected bond sales come from future issues of 2010 Measure D (\$130,000,000) and 2012 Measure E (\$120,000,000) anticipated in 2018 and 2020. Cost of issuance is estimated at \$500,000 each for the next two issues. Other revenues consist of projected interest income that includes \$16,000 received in February.

Budgeted and Project expense is a combination of committed costs and project budget balances for those projects authorized by the Board. The budgeted and projected expenses include program costs for program payroll estimates and program operating cost, including consultants, audits, attorneys and financial advisor fees.

This report includes notes as to the source of the information and will continue to be refined. Report #13 is a snapshot as to the estimated cash position as projects are approved by the Board of Education.

- C. The new liability for vendor contract retentions billed, not paid, is the net of the Contract Retentions and Cash with Fiscal Agent. The amounts are reflective of financial data from MUNIS and are displayed on Report #1, Bond Program Key Performance Indicators (page 1) and on Note 15 of this same Report #1.
- D. Accounts payable is reflective of financial data from MUNIS and are adjusted at June 30 fiscal year end.
