# To the West Contra Costa County Unified School District Board Members and Superintendent:

I am the president of the NAACP, Richmond Branch. The Richmond Branch has been working in the area since it was chartered in 1944. Its principal objective is to ensure the political, educational, social and economic equality of minority group citizens of United States and eliminate race prejudice and other social injustices.

We have reviewed the presently proposed maps delineating the change in election of trustees from district wide to trustee wards. The members of the Education Committee within the Branch make the following observations and recommendations from the online information presented to date:

- We believe that Trustee Wards would further assist in giving a voice to those constituents who are least heard.
- Based upon the demographics and areas of residence for board members, the grouping of constituents, least represented on the Board resides in the western most part of the county in the cities of Richmond and San Pablo, and the unincorporated of the County.
- It is our opinion that the map draft that outlines the best solution for these underrepresented constituents is "Cities and Schools B."
- To better inform constituents, we further recommend that a more intense outreach of information, about this anticipate change should be conducted by local grass-roots organizations, i.e. CBO's, Churches, teams of bock walkers with door hangers, flyers, etc.

Finally, the Richmond Branch is poised to partner with the District to assist with any effort that will help improve access to a better education for every child in our community.
