### **Negotiated Salary Settlement Disclosure – Chris Mount-Benites**

Enclosed is the Negotiated Salary Settlement Disclosure letter for the tentative agreement with United Teachers of Richmond (UTR) which was approved by the County Office of Education on September 13, 2017 and which went to the Board for approval at the September 20, 2017 meeting. Ratification for the UTR settlement was held on September 15, 2017 and passed by an overwhelming 80%.

### **Biography**



Richard Rothstein is a research associate of the Economic Policy Institute and a fellow at the Thurgood Marshall Institute of the NAACP Legal Defense Fund and of the Haas Institute at the University of California (Berkeley). He is the author of *The Color of Law: A Forgotten History of How our Government Segregated America*. The book recovers a forgotten history of how federal, state, and local policy explicitly segregated metropolitan areas nationwide, creating racially homogenous neighborhoods in patterns that violate the Constitution and require remediation.

### Psychological/Mental Health Support Services – Steve Collins

At the September 6, 2017 Board Meeting there was a request concerning what Psychological / Mental Health Services were available within the district. Listed below are the support services currently being provided.

### **School Psychologists**

Each school site has a school psychologist assigned to assist with the mental health needs of the school community. Under LCAP funding, many schools have additional psychology time at their sites to expand mental health services to students. Psychologists may provide counseling to students individually or in groups, support staff in working with students who are experiencing emotional difficulties and/or trauma, assess the psychological needs of students, provide trauma informed care, and assist with referrals to community counseling resources. Educationally Related Mental Health Services (ERMHS) are available for special education students who need mental health services in order to benefit from their I.E.P.

### **School District Crisis Team**

School psychologists and school counselors, including community mental health partners, are part of the district crisis team. When a crisis occurs, the team will assemble at the school site to provide emotional support to students and staff. Crisis team members are trained to prevent and prepare for psychological trauma. They are available to evaluate psychological trauma risk, provide interventions, and respond to psychological needs. Interventions are designed to reaffirm physical health and perceptions of security. Students, families, and staff are referred to the appropriate school based and community resources for post-vention as needed.

### **Mental Health Triage**

The Triage Team is a collaborative effort between County Mental Health and the Special Education Department to collaborate and coordinate services for students with the most intensive mental health needs and that may be at risk for out of district placement.

### **Clinics**

WCCUSD School Based Counseling Clinics operate at Highland, Pinole Middle, Sheldon, & Tara Hills. Individual and family counseling is available for Medi-Cal eligible students at these sites.

In addition, Wraparound services are available for Medi-Cal eligible students throughout the district either through the school based clinics or community mental health partners. Wraparound is an intensive, individualized care management process for children displaying serious emotional and behavioral needs. The Wraparound process is considered a higher order of (mental health) care, in which a team of individuals who are relevant to the well-being of the child, collaboratively develops a personalized plan of care based on presenting needs. This family-centered and strength-based process consists of building a team with the family, identifying and building upon the family's natural supports, incorporating professionals from schools, mental health agencies, social services, and/or community organizations, in order to address needs across multiple domains.

### School Based Health Centers & Community Based Organization Mental Health Providers

School Based Health Centers, coordinated by our Community Based Organization partners, include built facilities and services at Coronado, DeAnza, El Cerrito, Greenwood, Hercules High, Kennedy, Pinole Valley High, and Richmond High. The school based clinics offer an array of services including mental health, dental, physicals, and confidential services. While there is no constructed clinic at Helms, DeJean, and Crespi--all sites also offer a wide array of mental health services and physical health/confidential services are provided by the Contra Costa Health Services mobile clinic. Peres Elementary has a stand-alone dental clinic.

District Community Based Organization (CBO) providers provide mental health services to students during the school day on WCCUSD campuses. The majority of these services are provided to Medi-cal eligible students and funded through Medi-cal contracts with Contra Costa Health Services. Medi-cal providers include: Bay Area Community Resources, Community Health for Asian Americans, Familias Unidas, Seneca Family of Agencies, West Contra Costa Youth Service Bureau, and YMCA of the East Bay. Our core CBO mental health providers also provide trainees and interns on campuses to provide additional mental health access for all students. A number of CBO providers (beyond those listed above) have received external grant funding to provided extended mental health services at WCCUSD sites, including case management, wraparound services, and services to non Medi-cal students.

The District contributes partial funding for two licensed clinicians at DeJean Middle School and Helms Middle School through Contra Costa Health Services.

School sites also have the option to purchase additional Mental Health Services through our CBO providers to meet non Medi-cal needs at school sites and/or to expand Mental Health Services on their campus.

Dear Superintendent Duffy:

Our office has reviewed your District's 2017-18 Negotiated Salary Settlement Disclosure documents that provide the details for the tentative agreement with the United Teachers of Richmond (UTR) bargaining unit of the West Contra Costa School District.

We agree with the District's certification that it will be able to provide the necessary funding for the removal of the first step and first column of the salary schedule, the two steps moves for the current school year and two additional hours of professional development for all bargaining unit members, the \$1,500 off-schedule payment for Nurses, Psychologists and members at the top of the new step 27. The Nurses will be transferred to the Psychologists' salary schedule and the Nurses' schedule will be deleted. Based on our analysis of the disclosure documents, it appears this agreement will result in an increase in costs of \$2,612,238 to the District.

The district will utilize general funds to cover the increase in costs for this agreement. We agree with the District's assessment on affordability based on its 3-year multi-year projection. We appreciate that the District acknowledges the need to make appropriate cuts to reduce deficit spending in out years if deficit spending continues.
