#### Center for Youth Development through Law Contract - Nia Rashidchi

The 2017-18 Center for Youth Development through Law contract will be on the October 4 Board agenda for approval. We are providing the following background and outcome information to ensure that Board members can make an informed decision.

During the 2017-18 school year, the Center for Youth Development through Law (CYDL) will support teams of students at our six comprehensive high schools (DeAnza, El Cerrito, Hercules, Kennedy, Pinole Valley, and Richmond) to participate in the Mock Trial Program Competition hosted by the Contra Costa County Office of Education. The total number of participating students will be between 84 and 120.

Participating students acquire knowledge about law and legal professions, and develop legal analysis and critical thinking skills, teamwork abilities, advocacy and presentation skills, and the ability to conduct themselves appropriately in a professional environment.

### **2017-18 Contract deliverables:**

CYDL will provide attorney coaches who will work with students at each school to teach them about the criminal justice process and how to conduct a criminal trial. Coaches will develop a team at each school with students serving as prosecution and defense attorneys, witnesses, law enforcement officers, court clerks, and bailiffs. Each team will compete in at least four rounds of the High School Mock Trial Competition at the Contra Costa County Superior Courthouse.

#### 2017-18 Measurable outcomes will include:

- 1. By the end of the program, 100% of participating students will understand the following aspects of the United States justice system: the role of trials, rights of criminal defendants, trial procedures, the contrast between the roles of prosecution and defense in a criminal trial, and the roles of different law-related professions. CYDL will measure students' understanding through post-program assessments.
- 2. Participating students will improve their persuasive argumentation skills by an average of at least 40% over the course of the mock trial season. Persuasive argumentation skills will include the ability to develop evidence-based arguments and the ability to critically evaluate alternative arguments. The level of improvement on these skills will be determined by a comparison of preprogram assessments and post-program assessments completed by teachers and coaches.
- 3. At least 75% of participating students will improve their public speaking ability. This will be measured through comparison of pre- and post-program assessments completed by teachers and coaches, and through students' post-program self-assessments.
- 4. At least 70% of participating students will improve their ability to work effectively as a member of a team. This will be measured through comparison of teacher and coach pre- and post-assessments of students and through students' post-program reports.

#### 2016-17 outcomes were as follows:

CYDL Mock Trial Program served 96 students at five high schools last year. More than 90% of participating students reported that the program improved their public speaking abilities and their

knowledge about the legal system, 80% reported that the program improved their communication skills and their ability to work in a team, and 88% reported that the program improved their self-confidence. Twelve of the participating students won awards for their performance in the Contra Costa County Office of Education Mock Trial Competition.
