Juan Crespi Middle School Renaming - Matthew Duffy

The Juan Crespi Middle School community has started a process to explore a new name for Juan Crespi Middle School. Students, teachers and community will be involved as part of the process. The Board will be kept updated of the process. No action will be taken without Board approval.

Financial Impact of AB 218 - Tony Wold (Phyllis Rosen)

AB 218, known as The California Child Victims Act, went into effect on January 1, 2020, and will expire on December 31, 2022. The bill encompasses a three-year period during which a claim for childhood sexual assault can be filed regardless of how long ago an alleged event may have occurred. In addition, it extended the general statute of limitations for filing a childhood sexual assault claim from age 26 to age 40.

These revival claims have been occurring statewide and the cost of the additional litigation must be funded. Liability coverage for these claims is based on a school district's insurance program in place during the year the event occurred.

From 1987 through 2007, the District was a member of Schools Excess Liability Fund (SELF) Excess Liability Program. SELF is a not-for-profit Joint Powers Authority (JPA) providing excess liability coverage to its members beyond the primary coverage they purchased from an underlying JPA, covering claims that exceed \$1 million or \$5 million. As a member, we agreed to pay contributions set by the SELF Board in exchange for coverage to fund liabilities. Those included liabilities retroactively imposed by laws, such as AB 218.

In June 2020, SELF's Board approved the AB 218 Revived Liability Funding Plan, declaring a special assessment of \$46.6 million, based on a preliminary actuarial analysis of the fiscal impact. SELF developed per-year funding amounts calculated as a pro-rata share of each district's original contributions and identified four program years for which funding will be collected: 96-97, 99-00, 06-07 and 16-17. Our District participated in three of those four years and has received an invoice for \$251,058.28. SELF calculated the District's portion of the overall assessment as follows:

The District anticipated this increased liability cost as part of our adopted budget and this invoice will be paid from the Risk Management budget that was set up at the start of the year. We are providing this information to ensure that the Board is aware of the cost that is incurred even without any claims being filed against the District due the new laws.

Bonding Capacity Waiver Approved - Tony Wold

On Wednesday, January 13th the State Board of Education unanimously approved our waiver of the bonding capacity limit from 2.50% to 4.05% to be able to issue Measure R funds for our facilities program. We are currently monitoring the bond market to determine the appropriate timing for our first issuance of Measure R projects to ensure that we are able to continue to improve our facilities based upon the master plan and priorities.

Donation of Personal Protection Equipment (PPE) - Tony Wold (Martine Blake, David Johnson & Eric Moreno)

Good news!! We wanted to recognize Vivien Feyer who is the Refurbishing N95 Masks For All Project Coordinator with the Healthy Richmond Steering Committee for an extremely generous partnership of PPE including N95 masks and face shields to be used by our staff. Martine Blake brought this partnership to the District's attention and David Johnston and Eric Moreno from the Warehouse are coordinating the donation.

We will be immediately receiving 10 cases (2100) of N95 masks this week. In addition we will be receiving hundreds of face shields as well. This support will be ongoing and we appreciate the ability to continue to access quality PPE to protect our staff through this new partnership.

California Public Records Act (CPRA) Data Requests - Tony Wold (Phyllis Rosen, Bobby Jordan)

The District has been working diligently to create processes and procedures that provide timely information to the public about the workings of the District. To this end, the District, and the Board, operate numerous committees, advisory groups, and stakeholder input sessions. Inevitably, however, there always is the request for more information and the goal to make it transparent. We continue to strive to do just that, but there are other vehicles as well that the public can request information, and many due use these vehicles. One of these is the California Public Records Act (CPRA) process of requesting information.

The **California Public Records Act** (Statutes of 1968, Chapter 1473; currently codified as Chapter 3.5 of Division 7 of Title 1 of the California Government Code) was a law passed by the California State

Legislature and signed by then-governor Ronald Reagan in 1968 requiring inspection or disclosure of governmental records to the public upon request, unless exempted by law.

The law is similar to the Freedom of Information Act, except that "the people have the right of access to information concerning the conduct of the people's business" is enshrined in Article 1 of the California Constitution due to California Proposition 59 (the Sunshine Amendment, 2004).

The challenge for the District is that the definition of the requirement allow multiple requests and can consume significant time from staff responding to information that has been presented previously. In the Act public records are broadly defined to include "any writing containing information relating to the conduct of a public's business prepared, owned, used or retained by any state or local agency regardless of physical form or characteristic."

This definition is intended to cover every conceivable kind of record that is involved in the governmental process and will pertain to any new form of record-keeping instrument as it is developed. Only purely personal information unrelated to 'the conduct of the public's business' could be considered exempt from this definition, i.e., the shopping list phoned from home, the letter to a public officer from a friend which is totally void of reference to governmental activities.

Moreover, unless the public records of a local agency are exempt from the provisions of the CPRA, they must be made available for public inspection. Exemptions must be narrowly construed and the public agency bears the burden of proving that an exemption applies. Most of the exemptions under the CPRA are set forth under Section 6254 and are specific as to certain records or types of records, but under Section 6255 a general exemption exists where, on the facts of the particular case, "the public interest served by not making the record public clearly outweighs the public interest served by disclosure of the record".

One area of note relevant to the Board of Education is that the California Supreme Court held that when a public official or employee uses a *personal* account and/or device to communicate about the conduct of public business, such as emails or text messages, the applicable writings may be subject to disclosure under the California Public Records Act.

We are working on creating both a database of completed requests and a tracking system of the types of requests that do create a burden on staff to respond. Our goal is to create open communication and make information available. The following is a listing of the requests that have been received and processed this current fiscal year. As the process of tracking is just being established again, not every request may be in the grid as some emails direct to employees may not have been handled within the CPRA realm as they should.

We have created an email address <u>publicrecords@wccusd.net</u> to receive and send these requests will periodically update the board on the types of requests that are received and maintain a depository of them for future reference.

Partnering with Higher Ed to Provide College & Career Experiences for Students - Rubén Aurelio (Allison Huie & team)

Last week, we talked about how critical it is to develop strong relationships with our business and industry partners. The same holds true for our partners in postsecondary education. Through our relationships with postsecondary institutions, our teachers get additional professional development

opportunities and collaboration with postsecondary educators. Students come to understand direct pathways from K-12 education to postsecondary education and beyond. In many cases, students also have opportunities to earn early college credit.

Working together to implement the State's Strong Workforce initiatives, we have developed very strong relationships with our regional California Community College, Contra Costa College (CCC). With the support of CCC staff, we have been able to get many of our high school Career and Technical Education (CTE) classes approved as either dual-enrolled or articulated courses that offer high school students the opportunity to earn college credit. Some of our high school CTE teachers have even been hired as adjunct CCC instructional staff. In addition to these courses taken as part of the high school day, students also have the option to co-enroll in college courses outside of the high school day.

CCC's Certified Nursing Assistant program is one such program that is popular with our students in our Health Pathway programs. This is a seven-unit course approved by the California Department of Public Health. Each year, several WCCUSD Health Pathway students apply to and are admitted to the small cohort and begin their journey toward becoming fully Certified Nursing Assistants.

Another great example of partnering with postsecondary institutions is our partnership with the University of California's Lawrence Berkeley National Laboratory (LBNL). Several LBNL employees serve on a few of our sector-based Advisory Committees. Prior to our COVID-related distance learning model, LBNL was a frequent study trip destination to see science and scientists in action. This year, we are excited to announce that Pathway students will have the opportunity to participate in the LBNL Experiences in Research program.

This program will provide summer internships for students to gain hands-on experience with professionals at Berkeley Lab. Students will be working directly on cutting edge projects alongside experts in various STEM fields. Projects will be focused on different aspects of STEM including experimental research, administration, communications, and more.
