El Cerrito High School Football Game and Safety Measures - Nia Rashidchi

Last Friday, September 2 during the El Cerrito High football game, there was an allegation that at least one individual was carrying a gun. The El Cerrito Police Department (ECPD) was immediately notified in regards to the allegation. The allegation was confirmed Tuesday, September 6 by 2 additional students. WCCUSD staff member, Libby MontesNation, is working with district safety officers and ECPD to ensure safety at tonight's game. District personnel is collaborating with ECPD in regards to the use of metal detectors for this week's game. Additionally, the Maintenance Department is working to create signs, for ALL high schools, that state individuals are subject to search, which will assist in supporting our law enforcement partners to provide a safe environment for our students and communities. District staff is working closely with site staff and the ECPD to ensure that the ongoing investigation is an effective process. We will keep the Board updated as more details develop.


