Bond Program Changes

- 1. District has received \$47 million in state bond fund.
- 2. Authorized for \$59 million additional.
- 3. In December Pooled Money Investment Board withheld \$10.8 for El Cerrito High.
- 4. Assessed valuation is going down in CCC. District will ask state to increase the limit for bonded indebtedness.
- 5. Interest income is declining.

Adams Middle School

Dasse 2008 Report findings:

"In Dasse's opinion, the structure could experience significant and likely irreparable damage in a moderate earthquake."

"In a severe earthquake, with intense ground motion at the site, it is conceivable that these deficiencies will pose significant life safety hazards and localized collapse in several locations of the building is possible."

Potential & Committed City Support

- District held joint meeting with all five city councils
- San Pablo may provide operating funds to preclude closure of Lake Elementary
- On February 3, Richmond City Council approved a motion to provide \$1.5 million to WCCUSD to keep open two elementary schools and Kennedy High School for 2010-11 that are recommended for closure.

Federal Stimulus Package

- Approved by the House of Representatives
- Senate Approval & President's signature expected in February
- When & how much is still unknown but funds will be for:
 - Additional Title I & Special Education Funds
 - Construction funding 1 year only
 - State pass through funding





"The multi year assumptions include \$1.5 million savings in 2009-10 and an additional \$1.5 million in savings in 2010-11 based upon school closure."

County Approval Requires by 2nd Interim:

- 1. List of reductions to the structural deficit
- 2.List of schools to be closed
- 3. Address the rising cost of health benefits

Essential Assumptions about School Consolidation in WCCUSD

- Student redistricting will be included in scenarios and if logistically possible will be adopted by the Board at the time of approving the closure plan.
- 2. The timeline for decision-making cannot be extended.
- 3. Closed facilities will be placed on the market for sale to pay off the District's debts dating back to the early 1990's state loan, COPS loan, voluntary integration, IBM.
- 4. State Budget crisis will push closures toward maximum number.
- 5. School closure is Categorically Exempt from CEQA. But CEQA studies must be completed when, as a result of enrollment shifts, a school needs to add 10 classrooms or increases capacity by 25% whichever is less.
- 6. The District must add student enrollment capacity in order to close other schools i.e. district must increase school size averages.

Estimated Closure Savings

- \$18.6 Million over next five years


2010-11

2010-11_(cont)

Grant

- Large enrollment elementary school that can be distributed across five or six nearby schools
- Population of that school is projected to decline over the next five years

K-8

- Mira Vista to K-7 in 2010-11 and K-8 in 2011-12
 - Has acreage for more classrooms
 - District may need additional seats for 7th & 8th graders in that area when Adams Closes
 - Can meet criteria for Cost Neutral K-8

Criteria for Cost Neutral K-8

While there may be one-time costs for changes to the campus such as adding relocatable classrooms, there are no on-going or additional operating costs. To qualify for adding 6th, 7th and 8th grade classrooms, there must be sufficient acreage for the additional classrooms without substantially displacing playground or other space for the current K-5 or K-6 students.

Gym space or specialty classrooms (science, music) would not be added. Seats available are limited to allow parents to choose to keep or transfer 6th, 7th and then 8th graders in or into an elementary school environment;

The K-8 program will be built around an elementary school schedule with 7th and 8th graders taught at standards in the core academic subjects in a self-contained model;

Cost Neutral - Cost Neutral K-8 cont

- In order to make space available for added 7th and 8th graders in that attendance area, transfers may be revoked and ancillary programs (child care) occupying school owned facilities may be required to move;
- Equipment for science labs, technology, textbooks, materials would be brought in to the K-8 school from other schools where available due to decreased enrollment or school closure; there would be no additional expense for equipment and materials;
- Students who wish to take instrumental music, foreign language, tech labs, career wheels, etc. would have to take them at other schools or in after school programs;
- Multi-subject teachers would be assigned to 7th and 8th grade classrooms rather than attempting to hire single subject teachers. In this respect, K-8 schools would help the district have sufficient single subject teachers for the remaining middle schools.
