Appointed Members

Explanations for Adding & Removing Schools to Scenario I & II

- Since Coronado has a High API I would be concerned about closure unless the concept making it successful remains intact somewhere else.
- I do not have enough data to determine. Given the criteria, I need to access the data posted on the website to make an informed recommendation.
- I think that is difficult to decide based on the presented data. I feel you could centralize administrative services district wide.
- Not sure about Adams/Portola due to the seismic issues.
- Concerned about Sp. Ed programs especially at El Sobrante.
- If Kennedy is closed, there is a high possibility of gang fights when the Kennedy students are placed in the other Richmond H.S. or Richmond High.
- This is the wrong approach.
- Kennedy does not deserve to be on both scenario lists.
- It appears these school shave alternate schools that are geographically close, to prevent transportation. Valley View has enough land to expand and accommodate the increased member of students & faculty.
- Both Castro Elementary and Portola Middle are essential for Special Education children
- I know El Sobrante is very small & dilapidated close it! and following this criteria along w/ population & geographics. Close the smaller population & run down buildings. Not sure which of the schools above are small & rundown.
- Portola must be rebuilt @ Castro or WCCUSD loses \$60 million.
- Do not move H.S. students! Cost more in police protection. Expect too much from teachers to deal with problems.

- Can't recommend. However: growth should be more heavily weighted more than straight scores on API.
- I am not familiar with all of these school sites. What about some 6-12 options? I think options should be explored for collaboration between schools, city and industry, to enter into shared use agreements.
- Prefer k-8 increase instead of closing Kennedy. I do not want to see the closure of high schools. Sell the admin. Bldgs and move the administrators to the school maybe the admin. Will not remain so aloof from students, parents, & faculty.
- Better capacity and strong local support for converting to K-8. This list is also broader geographic distribution so all in the district have k-8 choice.
- I say no to k-8.

- Schools that have really significant special education programs absolutely need to be kept in totality.
- K-8 would benefit our Special Education children with the consistency they need. Providing that their initial class can be moved intact. Our children do not do well with change.
- I don't like K-8 try to keep schools K-5, 6-8, 9-12
- None unless east neutral and even then, it is not a good idea.
- I feel that MS kids need the electives & need to be separated from ES & HS. It is the time they find themselves, learn how to protect themselves, & stand up for themselves.
- Neither is 'better' if the choice is wrong i.e. the criteria fail to account for other options (see comments)

Other Comments on School Closures

- If Coronado is so high in API reconsider closing it or reconsider where to send them too.
- Please reconsider Coronado.
- We need to have as much data on the 10 Consolidation Criteria in writing during these discussions to make better judgements.
- I believe this may be easier in the future, for those who do not know these schools, to include a copy of the map showing enrollment boundaries. (at least one copy for each table to shave paper!)
 I believe that the district should look into also closing some admin sites and relocating these to other areas; such as Seaview, Sera, etc. in addition to these school closures.
- I feel that funds should be saved elsewhere. Look at the areas that can be cut. Sell other district owned properties that are not schools. Consolidate staff at Seaview and Serra.
- The district has successful consolidated-grades campuses at Hercules and Stewart These should be models for creating <u>more</u> K-8 & 7-12 campuses, which have academic benefits. Cost-effectiveness, and reduce drop and rate. It allows students to suffer fewer transitions.
 - The Woo proposal closes fewer total schools but saves more money.
- Make more middle/high school combination like Hercules have more community involvement.
- Considering the geographical set up of the schools and families' economic situation, school closures do not seem to be the best solution. The President of Kennedy mentioned how some families in Coronado (?) cannot afford cars' to transport their children. Bus systems would be just as troubling to employ if students live in different cities.
- I feel this meeting lacks information upon each school that has been considered for consolidation. You provide a list, however reasons that specify why or why not these schools of both scenario 1 and scenario 2 are not present. In order to receive a clearer look and understanding, I need specifications. However, school closures are not in my interest. I believe another alternative is available, which is

- 6-12 campuses such as Hercules Middle/High school. Take in consideration the students perspectives. Please see white paper under Whitney Vuong.
- Closing school, boarding them up & fencing the land, contribute to property value reduction there by reducing money for schools. Squatters, criminals, drugs & decay will follow.
- Too many schools in our district have unbalanced boundaries. Changing boundaries might close school for you. Person who spoke had a point @ balanced boundaries try to keep all H.S. open & put non. School personel in empty H.S. wings. Do not sell property yet marked is so low.
- My concern is for the Board to move ahead on the school closures. This has been put off for a couple of years because it is hard to do politically, but it must be done now for the future of the whole district.
- The current vs. max. enrollment chart, map w/ reconstructed schools/non-reconst. Schools would be good to have avail. I printed some things, but there was too much duplication on the web to print everything.
 - Other scenarios should be handed out before the group begins, not after.
- The district is in a much stronger position to lobby for Nat'l Health than we seem to realize here.

The State of CA has not met its obligations to fund schools/this district.

Therefore, it is time to push back, & make it known what we expect from the Fed. & State government.

Public Comments

Explanations for Adding & Removing Schools to Scenario I & II

- If you select #2 don't waste \$3.7 million already spent on Portola to Castro project. Castro site is "shovel ready" to sell in federal money pledged to states for projects ready to go.
- If KHS closes, where would they go? Enrollment is unfair criteria, when the borders are drawn to sent nearby families to other schools.
- Crespi had significant drop in enrollment. 2006 K-8 study points to lack of enrollment at Crespi due to academics & Safety. Making Crespi K-8 will not solve district funding problem. Combining Crespi & De Anza will save more than closing 2 elementary schools. Also De Anza is eing rebuilt now, plans can be modified to incorporate separate campuses. Also consider combining De Jean & Kennedy.
- I am not in favor of either proposed scenarios.
- Given that we are a district PI3, academic achievement deserves strong consideration.
- Olinda has good test schores and an excellent parent participation. Put Olinda off Scenario 1 and replace with a <u>low performing</u> school.
- Coronado API 805
 Kennedy Not safe for students to go to RHS.
- Consolidate Gompers & no campuses continuation at central site.
- Geographic equity to De Anza feeders.

- Don't close high-performing schools & don't close Kennedy; violent issues involved w/ Richmond.
- Coronado should not feed into Nystrom. Nystrom should feed into Coronado.
- Collins is located down town, <u>walking</u> distance to the library & other study trips. There are children there 4th generation pinole.
- Other alternatives need to be explored more fully before closing schools. Our taxes are being wasted.

Explanations on K-8

- Able to house more.
- Also, the loss of QEIA \$ is more (\$900,000) than the savings (\$800,000), without considering the academy \$ that cannot be recouped if students go to another school with the same program.
- Olinda & VV are both high performing schools, with safe campuses environment & strong parent involvement. To prevent further enrollment loss, the Board must demonstrate willingness to listen & honor parents' choice for performing "magnet" schools.
- Scenario II requires too many kids to relocate, please vote for Scenario I.
- Olinda has had a long time interest in K-8 Our student population falls off after grade 4 as parents leave for alternatives to middle schools (out of district) Lost ADA!
- Valley View Elementary has <u>excellent</u> academics and transfer rates are huge.
 Valley View is the public school many <u>choose</u> over their own local school. I transferred my son to VV. <u>Keep</u> the schools that are doing <u>well</u> that have earned the trust of the majority. <u>Build</u> on what is working. Valley View <u>is</u> working and would take in more students with open arms.
- Why not make all elemen. K-6 or K-5 part of reason for small schools and Lopsided programs @ middle school level.
- Social class segregation. Not healthy to regard social development. Of adolescents, costly to convert elementary school facilities for middle school curriculum. Taxing on teaching/curriculum to accommodate in K-8. Even in K-8 the older grades students are kept separate from the lower grade (younger) students.
- These schools have high performing K to 6's adding 7 & 8 would be a natural flow, a natural addition to a great school.
- K-8s are more expensive for operating costs. K-8s have not been studied thoroughly & won't be if they are involved in this rush to close schools.
- New facilities & large enough to house all the strudents.
- Mira Vista is a large enough campus & making it K-8 will help with the closure of Adams.

Other Comments on School Closures

• Taxpayers are paying for 4 WCCUSD Bonds. If the Board votes for #2, taxpayer \$ will be wasted - \$3.7 million already spent on Scenario #1 will be wasted. The time and effort put into the project will have been wasted. The Environmental

Report for Castro which has been paid for and the Board voted to accept will be wasted. The federal government is ready to pay for "shovel ready" projects such as the Castro Site.

- <u>Please</u> continue to explore alternatives to closing schools.
- I am concerned the process of public comment after 1-hour discussion robs the committee of knowledge, information and alternatives the public can provide. The committee knows their area, but may e uninformed of outside communities.
- I would like to know if the Board has actively engaged the powers that (state trustee or others) to discuss what would get WCCUSD more time to go through this process in a more thoughtful manner. Can we fundraise to cover some of the deficit? Should we try to pass another bond measure (see alternate scenario 1)? Can we do local taxes to find small neighbor hood schools and what timeline we have to make that happen? Can we establish fees for "magnet schools"?
- Continue to look at District staff facilities for closure. Save operational costs and move <u>staff</u> rather than students Use under utilized space in renovated school to house these facilities and programs.
- When you make your decision, please keep in mind what should be the priority at any school: a high quality education.
 Please do not close high performing schools and keep open low performing schools, expecting a miraculous transformation for the better. Close down the bad ones. Especially Crespi!
- I hope that this and if the district will have to abort some more students over if it doesn't have to close schools. Its not good for Richmond kids to be crammed into over crowded schools or portables and other areas not feel any pain at all.
- 1. Create more independent study & district controlled "vitual" (charter) school-using internet.
- There are capital campaigns where is the operating campaign? Please seek money from businesses and the communities before closing schools.
- Tackle "low hanging trusts". Have a PR firm to set forth negative publicity about IBM refusing to forgive \$4 million on out dated and depreciated equipment.
- Other proposals should be made available @ these meetings.

Explanations for Adding & Removing Schools to Scenario I & II

- Close Crespi. Kennedy closing down is a safety issue.
- Kennedy: <u>Safety is major consideration</u>. Collins: SP ED classes at Collins are well taught.
- I can chose any school because I thinking in the safe and the transportation for the kids.
- Closing of schools on both scenarios.
- Close Crespi & El Sobrante and make Valley View a K-8 school.
- Closing Kennedy would exacerbate existing tensions between North & South Richmond. Shannon is a well-functioning school with a large population of students who walk to school.
- Choosing this scenario will displace almost 2,000 less students.
- As explained, Kennedy closure could cause turf wars.
- Make 7-12 & K-6 Schools.
- Coronado is highperforming. Crespi: <u>close this low performing and is disrepair</u>. Valley View high performing great community large property.
- Neither scenario, but do agree that El Sobrante should close b/c of low student population.
- Take all 6th grades out of middle place them back to elementary. Send all Kennedy to El Cerrito takes care of North & South Issue.
- All Elem back to K-6th open more room middle
- Close Adams & Portola
- Portola has few students misplaced than Adams.
- Most in need of maintenance & repair.

- Fairmont should be considered. Make El Cerrito 7-12.
- Crespi should be considered for K-8.
- I like the idea of making De Anza 7-12 students would be served better than in K-8 (the way proposed).
- Valley View is a lg property & strong parent commitment; Ellerhorst lg property & strong parent commitment.
- The above school has high API (consistently) probably because of high parent participation.
- Make the Elementary schools K-7 and high schools 8-12.
- Close Alvarado, Seaview, other non-school sites and sell.

- Only if it is cost neutral & teachers can be found.
- Valley View has large 13.5 acres yard that can accommodate K-8
- Large tighter communities, newer facilities, central to areas.

Other Comments on School Closures

- I do not feel any schools really should be closed as all these areas should have neighborhood schools.
- How one can ask Washington D.C. for help, because if they can pay for war they can pay for help for the US kids education.
- I am intrigued with the idea of approaching Chevron for help for the schools. If the board is going to close schools, let them make the decision based on the best data they can find. It is <u>extremely</u> hard to make dispassionate recommendations while at the same time teaching at one of the potentially affected schools.
 - I appreciate your attempt at an open process.
- It is apparent from this meet that the community needs much more information to make informed decisions.
- Having outside consultants stand around and walk and get paid for it is not really cost neutral. Not sounding the alarm about economic problems until after elections stinks.
- We as a community need to work together during this process. This is not new information should have started these discussion last year past the February Budget Meetings. Then the City governments could have been more involved.
- If you're closing a school, can members of that community create a charter school, so they can demand a facility.
- DO NOT CLOSE PINOLE VALLEY HIGH SCHOOL.
- With reduction in enrollment & school closures management needs to be reduced also. Close Alvarado & sell.
- I think the community needs more time to evaluate the Scenarios. High diversity school creates behavior problems. May have negative impact to out kids education! Why can we get bail out \$ for our kids? Can we go to other resources before we actually close schools?
 - Bad performance schools has a <u>large</u> impact on property value!
- Include costs of charter schools that the district is sponsoring \$ cost efficiency!
- Scenario 1 impacts over <u>1700</u> students less, resolves seismic dangers in 2 locations.

Explanations for Adding & Removing Schools to Scenario I & II

- Stege is too low on API. Closing Coronado really bankrupts SW Richmond because of its API score.
- "appeal to Washington for a bailout" keep all the schools open raise taxes.
- Prior consolidation unfair to students.
- Olinda enrollment has been steadily climbing. Many families transfer their children there because of the high API and high parent involvement.

- Too dangerous to close Kennedy. Portola has seismic issues Crespi is underenrolled.
- Close Crespi.
- Better sinorgy.
- <u>I favor 7-12 campus!</u> Close Crespi! Make Sheldon K-8 & consolidate El Sobrante to Murphy. This makes all renovated school fiable. Keep Olinda & Valley View. Make Kennedy a small High school & consolidate all other small programs to this campus.
- These scenarios were not well informed discussions.
- Neither Shannon or Collins should be closed. Consolidating 7-12.
- Coronado is a highly successful school.
- If I had to choose I would pick scenario #1.
- I think De Anza should close.
- There is no scenario I or II look at all of the facts and options.
- Close Portola & Castro make Stege K-8, Wilson & King K-6 move 7-8th graders from that area to the New El Cerrito High and add 7-8th graders as modeled by Hercules.
- I would like to see Valley View and Olinda merge on Valley View campus. (Both have high API scores)
- Neither one. Closing schools is unacceptable this early in the game. Vacant school properties should be assessed & sold before any more schools are closed.
- My years at Valley View were probably the best of my academic life.
- I do not think that this <u>many</u> schools should require closure at one time.
- Close Alvarado Adult merge onto Kennedy campus with leadership & Kennedy HS.
- Size-enrollment; school location; academic achievement and academic equity; geography; transportation; land value; etc.
- It seem like those are the schools that have the most negative means to staying open.
- Make De Anza 6-12.
- Keep all schools open!
- Please don't close any school. As a parent I say that we can sell things or have fundraises to make money. (Favor no sieren ninguna escuela como pade yo digo que podemos vender cosas hacer rifas para sacar fondos.)
- Parents might pull students from district affecting ADA. Issues of gang activity combining Kennedy & Richmond students. Special Ed issues would create expenses in moving student to other sites.
- Fairmont is a small school adjacent to BART and I son more valuable property.
 Olinda is a higher performing school on more open property with a better
 program. Valley View is on a large property with space to grow and keep better
 access for emergency evacuations and a excellent program that the community
 supports.
- Fairmont is small and has a higher value property. Adjacent schools have capacity for Fairmont students Valley View and Olinda are higher performing schools.

- Don't combine gang territories!
- Leave Collins open.
- Neither scenario. Sell non-school properties first. Get state to forgive district debt. Move other programs adult ed. or continuation studies to one of the nearby high schools.
- Charter school.
- Don't close Collins or Shannon. As Hercules is expected to grow those schools will be needed.
- I've always felt the district should make all elementary schools K-8 do away with middle school system.

- Close Riverside Close Sheldon move staff support from Seaview/Alvarado to Sheldon.

- Please do not move into communities base on API scores.
- Process flawed beyond redemption. No information provided on other elements of financial plan. Prove to us that schools <u>need</u> to be closed. You have not done that.
- This would move towards a model of K_8 schools in the district to (1) ensure you keep students in west county to at least 8th grade & (2) potentially resolve the number of school closures.
- None I want electives for Middle School students. Keep our Middle Schools. We cant get enough teachers for K-8 in math & science. We cannot afford K-8.
- I don't support K-8. I don't believe they will be cost neutral. I don't think they will provide the level of education that a true middle school would.
- I do not favor K-8. I don't feel K-8s are fiscally, fundamentally, or emotionally viable option.
- Safety: how does a naïve kindergarden child communicate with a 7th/8th grade sexually active person? Kinders will be vulnerable to sex & drugs.
- None. Unsafe for younger students.
- None. Kindest 1st graders would be vulnerable to adolescent behaviors; sexuality, dugs & bullying.
- Make a high achieving elem school a K-8. Like Valley View or Olinda. A natural flow to a great school.
- Has new facility, not at max capacity for cost effectiveness. Murphy will be at cost effective number if merged with El Sobrante.
- Better sinorgy.
- If Adams is closed this might make sense.
- Help w/ Adams, but cost neutral is not middle school.

- Kindergarteners should not mix with 8th graders on the Crespi campus. Make Sheldon a K-8 to encourage the enrollment to go up! Make Portola a K-8 to absorb Castro.
- Collins has to many good things happening there. Not only school, but in little leagues.
- Got P.D.
- What is the data around De Anza K-8.
- Close De Anza do not put the money into it.
- Selling off empty properties and looking at administrative management positions that can be eliminated first.
- Don't close Shannon! STOP MOVING US!!
- Don't close Shannon school because then you will move us again.
- Close Crespi. Yes, Pinole Middle and Helms.
- I am not familiar with the situations.
- It is only a poor school because there is no support. It is ignored and shouldn't be. Those children need their school two. You wnt more to go there then make it better. That is the districts job to begin with.
- Those students could really benefit from remaining in the smaller, nurturing environment. These are very poor student who will not be able to pay for transportation to other schools BUT a better principal is required. One who can encourage experienced qualified teacher to work there.
- Valley View has a LARGE campus that can accommodate the children.
- High performance can continue unto those upper grades. Academic performance must be taken into <u>consideration!</u>
- Castro could absorb some of students from Portola, which is seismically unstable. Mira Vista could absorb remaining Portola students.
- Merge Crespi into De Anza & also feel the district needs & look at private sector and look at work furloughs & partial payment of medical.
- Collins K-8 close Crespi have them attend Pinole Middle. There would be 2 K-8 in Pinole for ½ of the city. Other ½ Pinole Middle.
- What if after consolidation schools are then over crowded and in a few year we will then need to look at expanding & have new school?
- Coronado is an excellent performing school and could meet district enrollment # of 450 as a K-6 and even more as a K-8.
- Make De Anza 7-12 (merge Crespi onto DeAnza).
- Need to save money for other schools with better attendance.
- Alot of these schools are so small and make more sense to be infused with elementary school.
- Valley View has space to grow larger & be divided age group.
- Please do not close our schools.
- You can lower the some peoples salary to give some to the schools. (Pueden bajar el sueldo de unos para darle a otras un poco.)
- What expenses would be incurred in converting schools to a K-8 configuration? Given the expense is it worth it?

- I believe we need to spend our time and energy on revamping middle schools instead of closing them. Our children nee Jr. high bands, dances, flag football etc.
- N/A, I don't think K-8 is a good configuration for younger students.
- Low enrolment should get more students with more grades if security is there.
- I think Valley View could also serve as K-8 campus and move Crespi students there. Every HS attendance area should have a K-8 option. We should have done this two years ago when we looked at.
- De Anza 1. Larger that PVHS 2. New
- Location, size; test scores.
- Any that could accommodate K-8.
- VV has all space 13.5 acres & the parent involvement to make K-8 a success.
- I prefer a 7-12 scenario. I attended a 7-12 gr. School there were many offerings for 7th & 8th graders at a high school, where at a K-8 school electives are limited.
- Close Crespi ad K-8 to Murphy, Olinda, Valley View or close De Anza HS. & use site as a K-8 site for Olinda, Valley View Murphy and Sheldon. Move El Sobrante to Stewart.

Other Comments on School Closures

- Reduce government, senate, and representative employee salaries. (Reduscan sueldos de los empleados de gobierno senado y representantes tambien.)
- Given that the district debt is loosely due to benefits costs, consider the higher salary, lower benefits proposal suggested by one of the table groups. They would foster support for individuals to become more selective with their planning for retirement and investments toward future livelihoods.
 This process of "involving" community members and soliciting input is quite brief and rushed relative to the years of increasing and cumulative debt that the district has so blatantly acquired.
- You need to explore <u>all</u> options for lost savings before hurting the kids by closing schools. Some would include: selling <u>all</u> school properties that are not schools, larger class sizes so you'll need fewer teachers. The studies I've seen do not support higher test scores or better education with smaller enrollments, renegotiate union benefits/contracts to eliminate life time benefits for families of retires (while retiree is living), re-negotiating <u>all</u> other labor contracts, ask organized labor for financial support, ask all teachers to pich in a % of their retirement portfolio to help pay off the debt their benefits packages created.
- At least one good school as far as API score which does benefit the community. Closing Coronado bankrupts SW Richmond.
- We need to see a chart with the shortfall in the budget, and the funds available from each element (i.e. property sale, benefits cost reduction, staffing modification and more).
- Please don't close never high school. Is very important open.
- I believe that the Bond has some critical decisions to make in other areas beyond school closures, including the safety of students @ Portola and the NCLB mandates. It is important that the school take sufficient time to study all potential scenarios before making decision on school closures. Absent this, I'm afraid the

Board may make decision that will not be in the best interest of students & the district.

- Please do not close Coronado, high API and a great program. Add 6th grade to this school and it meets the elementary school size. How many schools pay for transportation to their larger schools? How is it fair to compare us to them when they spend million for transportation and we don't. Keep our middle schools, NO K-8!
- I like one of the groups suggestions regarding displaced student should be allowed to go to a 792 school.
- Too little time!!
- The parents that are high flight risk to this district, and therefore represent loss in funding, have indicated their concern over academic performance and safe campus as top priorities. Therefore, it is important to the district's financial viability to offer and respect parents' choice of magnet schools like Olinda and keep it open.
 - Closing Crespi or consolidating to a 7-12 grade configuration should also save precious middle school resource like single-subject credentialed teachers; allowing for focus on making remaining middle schools better. Not to mention it save much more money than closing either Olinda or Valley View, and has a larger plot of land to sell for paying down debt.
- I feel district has done a poor job of seeking stronger narrowing sources.
- Reform the process public comment should come <u>first</u>! Public comment should come before "Talk Time".
 - Please explain why exactly a school is on a list? Why is JFK on <u>both</u> lists? Explain, specifically, what will happen to students & staff at a closed school. E.g. where exactly will JFK kids go? Where/how will the lines be drawn? What becomes of staff. (I would like to know the answer for <u>all</u> closed schools). Thank you!
- If we close Valley View & Olinda too many will leave the district & these schools need to be encouraged to <u>Drawn</u> people to the district!
- Collins is very special for Pinole we have to keep it.
- Be more creative. Be smart. We cannot afford to close these elementary schools.
 Upper grade students would have more of a life experience out of any closures or
 consolidations. Don't make our communities uproot young children whose
 parents may not have the stability or life experience to deal w/ this as parent of
 older children.
- Have the district students write to Obama and ask for govt help!
- We are being moved from school to school. First!! Seaview. Now!! Shannon. What school is NEXT!!
- If you <u>must</u> close schools El Sobrante is the only school whose numbers make any viable sense. Only Kennedy H.S. if you are intent on race riots.
- De Anza has low enrollment and is only partially redone. Close the school and sell the property.
- Look at all the facts. There are other options just do the work find them. And be honest with us with the facts. Before the next step, take the <u>first</u> step.

- Keep Collins OPEN for their Special Education facilities as well as their day care Miss Patty's, that is an excellent after school program.
- Don't close Pinole Valley High School, it has too much to offer to the community.
- Do not close any schools. (Especially Pinole Valley High)
- DO NOT CLOSE PINOLE VALLEY HIGH SCHOOL (see the "Yohann Pepa" written comment)

Explanations for Adding & Removing Schools to Scenario I & II

- I think the district needs to look at the safety issues of closing Kennedy. There are turf or set contentions that would make for severe safety issues.
- Less students will be affected by the closure. We need to actually take a look at the affects of the class sizes our children would be in if they had to relocate to another school due to a closure. I know first hand that MY children learn better in a smaller class room setting. Not only will the class size affect the children it would affect the teachers how different of how affective would they be for our children. PLEASE RECONSIDER! No school closure!
- Coronado: we need more information about facility conditions. Kennedy should stay and continuation programs be relocated to this site as well.
- Collins serves a diverse population and should not be closed.
- Not enough time to justify a selection.
- Neither scenario is well thought out to meet the needs of this district.
- Keep Kennedy students at Kennedy and add alternative schools and other District offices.
- Coronado has a strong, successful culture despite its many challenges, and is a
 vital part of a growing community that needs such a school. Costs can be saved by
 consolidating alternative continuation schools. Kennedy also should not be closed
 bring in more programs to use the full site, but do not put student success &
 safety at risk by moving the kids.

- I do not believe that K-8 under the required financial constraints is a good educational solution, but a fair number of parents do so implementing one more to accommodate them makes sense, and Mira Vista has room & is centrally located.
- If you can find an alternative please do it. The Spec. Ed community does not seem to realize that they may want inclusion when their students let middle school and their children may want the enriching experience of a middle school.
- Castro: it offers El Cerrito a middle school opportunity.
- Supplement proposed merging of Portola & Crespi Ms with their local high schools.
- Crespi: Maybe. Their population seems to have a more "elementary" attitude. The kids are seemingly less middle school-ish in their attitudes & behaviors & they might be more adaptable to a K-8. Also, it's a large underutilized site.
- None. K-8 is not a cost saving decision and degrades the quality of education for everyone.
- The district has already spent millions on Portola at Castro and approved it. We need to move forward.

Other Comments on School Closures

- A middle school should be re-built in El Cerrito, it is shown in the data that projected increases in enrollment will occur in El Cerrito. I believe that the district needs to be prepare for this. Also, I believe that every city in the district should have the traditional middle school model. I am not opposed to K-8 per se, but I would I would limit the number from 4-2. I think that Kennedy is a good choice in both scenarios.
- Thank you for conducting all these meetings and involving the public so thoroughly in this difficult process.
- The number one factor that should be considered in determining which schools should be closed is the question: "How will our decisions impact those students that are at the lower end of the achievement group?" the school district should look at equitable solutions to support EL students, low socioeconomic families, and special educations students.
- I used the scoring criteria that was provided on the district website. For reasons of time and complexity I left out available capacity & grade configurations. I compiled the data and applied the criteria and this is the closure scenario that resulted: Shannon = 16.7, Crespi = 12, Stege = 15.2, Grant = 15.9, Lake = 16.9,

- Coronado = 15.5, El Sobrante = 14.5, Kennedy = 11.8. Note: this scenario does not address the seismic issues at Portola or Adams.
- We cannot fully understand the situation without having information 1. On the operating expenses at each school; 2. The facility conditions of each school; 3. And the grants or other monies that would be lost if a school closes. (eg. Kennedy is set to lose a lot of \$ earmarked for it).
- Thank you for giving the community an opportunity to participate with this process.
- The districts willingness to listen to community input is much appreciated. Thank you.
- The district cannot just mold together schools into K-8 without a proper educational plan. If the district is to do this the 6-8 students need a diverse elective educational opportunity.
- The Data suggests: De Anza feeder area should close the most schools. Next Richmond, then El Cerrito & Kennedy.
- Reduce program offerings for middle school students at K-8 schools makes them undesirable from an educational perspective.
- Information provided on website insufficient, and rationale for scenarios provided unclear. Closing many of the schools result in reduce funding (Kennedy QEIA funds) or increased costs (special needs student placement) citizen dissatisfaction causes more transfers out of district & reduced ADA funds. There are many more examples. Does this really save any money?
- Tow thoughts; could Adams & Portola both be consolidated onto a slightly larger Castro rebuild? Or since the Portola rebuild would be a small school why not? Swap land w/EC and take Cerrito Vista Park for a middle school site. No impact on the Castro neighborhood and community let them have their K-8 and EC could have a continuous piece of park land on which to do as they please. Inclusion is not a site it's a right.
- Gated and talented education student gate program (in dow Castro) as well as neighborhood. <u>Gate program</u> is a renovative energetic progressive program that needs to be kept intact and be a broad base for more ambitious (educationally) program. It is a relief and wonderful opportunity for student that want more fresh ideas & activities for betterment and growth.
- I believe a K-8 in the El Cerrito aea would offer parents an alternative & that they wouldn't necessarily go to private schools. I think it would have been better to have California school districts that have closed schools. Last year several Calif. school districts closed schools Orange Co, Riverside, San Bernardino, San Diego etc.
- The District scenarios lacked explanation of what happened to Kennedy HS students, rationale for closure decisions, how it adheres to the criteria, phasing and a budget. On the surface, the District proposal appear to have little thought behind them.
- I have a concern that the cost & trouble of moving Portola students into portables when there was no rush to do so over the past several years even after investigative studies showed a "danger" here... if only now it's imminent to

- move, that doesn't make much sense. I have concern ne less of programs & losing EC support during the interim of having Portola rebuilt.
- WCCUSD should develop a school closure approach that impacts as few students as possible. This includes factoring in the increased distances students who already attend their assigned school will have to travel. Schools with high transfer in rates, and poor attendance by those in the school's district should be close. Castro would be an example. Well over half the students in Castros' district go elsewhere, so closing Castro does not impact them.

We are locking the doors of high achieving schools in the hills to students while closing successful, equitable programs like Castro. This will lead to unfair, discriminatory environment.

- Disregard Mark Woo's scenario. It will <u>increase</u> racial segregation and <u>increase</u> economic segregation. Also spending money to make Kensington K8 is making the richest school in district rich and more elitist.
- Favor re-build Portola Middle School at Castro site. This process has been dragged out for years by NIMBY opposition. It is time to move forward in this process.
- I am also a continuation teacher, and do <u>not</u> favor consolidating continuation programs. These students belong on small campuses (150-25 students). Small schools, at already existing sites, may work best if safety is not an issue. Consider that parents and community members want <u>neighborhood</u> schools; this allows for less disruption (<u>travel</u> by bus, etc) and more community involvement. Every community deserves schools that are <u>local</u> and serve <u>its</u> population.
- Take a stand! Yes we can!
- Build more scenarios use legal means take a stand with the state demand a bailout. Thank you.
- What I have seen has not satisfied me that all alternatives to school closures have been explored an exhausted. Cut \$300K in administrator salaries and overhead and save at least 1 elementary school, for example. Also, where is the plan to increase enrollment? With higher enrollment, we can save schools, jobs, & build community.
- Safety, well being and social experiences are so great at 6-8 grade. By keeping middle schoolers w/their own communities we can ensure this will happen! Scenario 1.
- Have we WCCUSD asked state to <u>retroactively</u> help pay for seismic upgrade we made voluntarily in WCCUSD for prior re-build projects with the large state fund (assembly 2006 bill 300) forgot name! thanks.
- I feel that you can not move a full inclusion that is not like anything else in the district. You will not know unless you come and visit Castro in action with full inclusion and normal students. You can not make it anywhere else like that it takes the teachers.
- I think the only impartial criteria for closure is the enrollment number as flawed as it is. I would be willing to pay a district wide hardship fee to bridge and delay the consolidation process. Is it too late to propose it? (don't call it a tax)
- Please assure Castro parents that the district will provide a successful fullinclusion program.
- Crespi: would make a lousy K-8. Parent are <u>not</u> going to send their kids there (many El Sobrante schools now opt out of district rather than go to Crespi.)
 Closing Crespi makes sense – its old, halt full & neighboring rebuilt middle schools have space. De Anza is huge & could accommodate a 7-12 & do it well –

- give El Sobrante. New "middle school" at De Anza & parents will stay in the district for high school.
- Can the money for Portola be used to rebuild Adams? Where do the Kennedy HS students get relocated to? I have a concern because there is no information on it. If Portola's teachers, programs and students are kept as the same community and blended with some of the Adams community I would feel fine with closing Portola if Adams was rebuilt/retrofitted & updated. I have concerns when the people on the committees feel they don't have adequate information.
- Closing schools is not a cost effective plan for the budget. The transition and additional funds are always underestimated. If the properties are sold they are lost to future growing populations. Already too many students don't graduate high school how is this going to help?
- People who would want to move to El Cerrito may change their mind. If they know El Cerrito has no middle school.
- Please <u>visit</u> the schools & see what is happening.
- I would like you to know I am a strong supporter on rebuilding Portola at the Castro site even though this is only one block from my house. I would very much like my two children to attend public schools in their community and believe based on the information being provided that this is their only chance at the middle school level.
- Unfortunate that no Board members were in attendance this evening.
- Portola Middle school is a high performing school in the district the only middle school in El Cerrito. Closing Castro will have a big impact on the students doing well there, but there are many other high performance schools in the district that they could be relocated to. The full-inclusion program could be put at several other schools. If Portola closes, then the current elementary students in EC will not have a middle school to go to, and as a result the district will lose many students.
- Portola needs to be rebuilt to maintain a MS in El Cerrito. But Castro's full
 inclusion program is needed for a large group of kids. Please consider moving the
 Castro full incl. program, intact to another site Mira Vista or Fairmont. Do not
 move Portola kids to Adams seismic danger and the flatlands not being served
 (walking to school as one example) are two reasons to not move to Adams!
- We do need to pull our local cities into the discussion. El Cerrito will benefit from rebuilding the middle school & strong land support. Is the district looking at neighborhood demographics? Both Kensington & El Cerrito have had elderly populations, and as their houses are coming into the market, both communities an gaining young families. While we may has a state-wide or our all drop in the school age population, we may not be experiencing this in El Cerrito & Kensington.
- Academically having multiply subject teachers and loss electives at K-8 would be lower quality education than middle school. Socially – this age the kids want to make new friendships with kids with the same interests, not kids who live near by – They need a big gene pool to find those new friends. They will not grow socially if their relationships follow an elementary school status quo. Logistically

- they need to learn to go to general classrooms, juggle the demands of multiple teachers and learn to be safe in the much larger environment of high school.
- If Portola closes and the students are moved to Adams I will leave the district and I know many other parents who feel the same way. Adams is more seismically unstable than Portola, so how can you even consider moving kids there? Portola already has portables on the lower level that can be used while Portola is being rebuild at Castro. El Cerrito needs a middle school! Please rebuild at Castro. Thanks for listening.
- Scenario 1 is less inequitable and will disrupt fewer schools & communities.
- From a community perspective, it is important for the city of El Cerrito to have a middle school. I don't have middle school aged children, but I would have been much less likely to go to Adams for PTA meetings, where as I was retire for 4 years (2 kids) here at Portola. That involvement has continued to ECHS I am also concerned about Adams being so close to the earthquake fault.
- I don't understand why schools are being closed and prisons being built! If children are educated they will avoid becoming criminals!
- I and Richmond parent with children at Madera & ECHS. I will leave the district if Portola closes. Although I have been very dedicated for more than 10 years and have served on site councils & other boards. If I have to sacrifice my own kids future to stay here, I won't do it!!! And many other parents in the middle class will flee, too.
- Portola middle is our neighborhood school. We live 7/10 of mile from the campus and <u>walk</u> to school. I do not want to drive my child to school. I will seek alternate education for my child, either private or out of district, if Portola closes. I know many families who feel the same way.
- I am concerned at the prospect of the district selling that 15 acres we will never have such a big parcel again. I believe that if we built a new school there, sent the Portola feeders plus Mira Vista, retained Portola staff and programs (advanced core classes, band, shop, etc) the school could attract/retain the middle school population. It seems to be an easier solution than rebuilding Portola at Castro, and we could keep that land. I believe that parents care more about students demographics, API Scores, and facilities than about the name of the city the schools is built in.
- Make Coronado K-6 to bring up their numbers to meet the minimum for their criteria – and they really want it! Do not close Kennedy – drop out rate will go up – and so will crime.
- Full inclusion is as much about the general ed students as it is the students with IEP's, it is the entire school culture. It is impossible to pick up and "move" full inclusion that works well as it does at Castro. API of 805 shows that our school is succeeding in educating all of our students.
- Please rebuild <u>public middle</u> school in El Cerrito! Please do not temporarily site Portola at ECHS. No "elite" middle school at ECHS. Please preserve special ed program intact if Castro is closed With all necessary resources! Yes it would be good to grow it to other schools, but it can only work if it happens in a calm well-managed way. Can't be accomplished with a lead foot.

- If Portola must close next year I would like to see it relocate into Portables on the Castro site.
- I have not heard adequate justification for disturbing the Castro full inclusion program. One speaker mentioned seismic stability problems at Adams, but apparently this involves only the existing structure and not the land on which it is located; thus it could be a site for new construction.
- Please move quickly to rebuild Portola. We've spent enough time on this more then two years already!!
- I felt that the reason for scenario II's existence should have been explained to us all namely, the Castro lawsuit. It was not even addressed.
- We live near the school and it would take us out of our way to go to somewhere else, we go to Portola.
- My biggest concern is how school closures impact communities particularly in the case of Middle Schools, how dose closing/consolidating Portola impact the community it serves? El Cerrito must continue to have a middle to serve student from Richmond Annex, Pt. Richmond, Kensington & El Cerrito.
- My big concern w/ closing schools is that moving schools out of neighborhoods reduces accessibility of public education for exactly the people who need it most. Also, neighborhood students ware centers for community building.
- The district need to provide a safe middle school for El Cerrito ASAP! Portola rebuild has been approved please move forward with it.
- Portola's strength in faculty & programs must be nurtured. Please invest in Portola's future.
- Please preserve Portola. Relocate Portola to Castro. This process has gone on too long already.
- Work Jim Rogers letter. Make this decision? Can temporary money help us? A MS in the city of EC help w/ the community of education for the kids. Has the district looked at what works in other districts going through this process?
- Not enough information Puts one community against another. Both solutions seem like bad solutions.
- Full inclusion is not a site! Let's go district-wide!
- Dr. Harter should consider auditing the Personal resources of some our Board Members to see if they have act gained from the different contractors responsible for the inadequate rebuild of our many school buildings.
- Stop dividing community members amongst each other it will cause problems later when the schools are actually being closed.
- I walk to school. If Portola was shut down all the school would be to far away to walk to. So please rebuild Portola.
- It is critical to keep a middle school in El Cerrito a good one that can feed El Cerrito High. All the Portola feeder should become K-6 I would put Portola in portables below the school or at ECHS. Adams should be closed due to earthquake.

- I would also like to know more about the alternative/continuation schools. They seem expensive, but if it is keeping kids in school and out of jail, they might be worth it.
- Portola should not be closed. We need a middle school in the Southern part of the district. If you close it & it will further reduce enrollment & income to the district & reduce property values which in turn will reduce taxes. Castro special ed program can be transferred to a different site allowing Portola to rebuild there. I also think that the disproportionate per student state contribution should be normalized throughout the state which would provide the district additional \$.
- I love Portola and it's like my 2nd home.
- Rebuild Portola at Castro site. Portola has excellent academic classes. We need to keep a middle school in El Cerrito to keep up our property value.
- This process feel like a charade it damages <u>community</u> does not build community.
- Don't close Portola.
- I feel very strongly that <u>new</u> middle schools are build not K-8. I come from Kensington Hilltop and was a strong supporter of k-8. I once we made the hard decision to send our daughter to Portola I CHANGED MY MIND COMPLETELY. Wherever you put it that will continue. Don't take away the success stories. The District can not afford to do this. Build on the strength here. Rebuild Portola at Castro!
- I believe the district should seriously consider furloughs for all teachers & staff to potentially save \$ to reduce #'s of school to close. Need to consider getting \$ from federal govt & private donors to save school.
- Save Portola! WE NEED A MIDDLE SCHOOL IN EL CERRITO. Thanks for letting the community voice their opinions on school closures.
- Please rebuild Portola at Castro site!
- Each community needs a middle school. We need one in El Cerrito attendance area! Please rebuild one at Castro. We have the money. We need to move on!
- Rebuilding Portola is the best decision so you can keep a Middle school in El Cerrito.
- Please please PLEASE! Don't close this school it meant a lot to me and my friends so please!
- I love going to school at Portola! It has great classes, teachers, and students! Why would you want to close such a wonderful school? REBUILD PORTOLA!
- Dear Bored, please, pleases rebuild Portola. It is a wonderful school. I
 know people who would hate to see it close and I would to. So, please REBUILD
 PORTOLA MIDDLE SCHOOL at the Castro site.
- This process is a sham. The Portola community is pushing their agenda, based on their self-interest, and not the interest of the district as a whole.
- El Cerrito must have a <u>middle school</u>. Otherwise parent will be forced to move to Albany of pay for private schools.
