As outlined in our positive school climate resolution, West Contra Costa Unified School District believes strongly in creating a District-wide, positive, relationship-based culture that is supportive of all members of WCCUSD that is grounded in Restorative Practices, Positive Behavior Interventions and Supports, and Trauma-Informed Practices.

# **Things to Consider**

- <u>Safety</u> includes the physical and psychological or emotional safety of all stakeholders;
- The long term planning and training to fully implement the positive behavior interventions and support framework, as well as full implementation of restorative and healing centered practices is essential to safety planning;
- Data rapidly changs
- Safety requires a multi-layered approach and is ever changing given the needs;
- Accountability is needed at all levels to ensure implementation
- Focus on social/emotional health continues to be the leading strategy in preventing violence on campus.

### TIER 1 Social/Emotional/Behavioral Strategies: Universal -- All Settings -- All Students

### **TIER 1 WCCUSD Climate Supports**

Tier 1 supports are universal and preventative measures to support all students Across our District, the following are in place:

- Clearly Defined Expectations at every school site
  - Consequence System that is restorative and responsive to student needs
- Social/Emotional Learning implemented in classrooms
  - District Curricula: Second Step, WayFinder (in progress)
  - Restorative Practices/ Community Building
- Climate/ Safety Teams to identify behavioral trends and determine supports
- District Behavior Matrix

### **TIER 1 Social/Emotional/Behavioral Strategies:**

- At a central level, we look at data to determine further supports for school sites
- Documentation of incidents to accurately collect data to identify needed supports for schools
- Documentation of intervention before student is referred out of class
- Required re-entry processes for students returning to campus after suspension that must included a documented intervention plan

### **TIER 2: Targeted Supports -- Some Students**

Tie 2 interventions are <u>supplemental</u> to the instruction and strategies used in Tier 1, and are often delivered in small group settings for students with similar presenting concerns.

### **TIER 2 WCCUSD Climate Supports**

- CARE and/or SST processes in place on campuses to identify and support students with additional resources
- Partnerships with behavior/mental health staff for targeted group support



### **TIER 3: Intensive Supports -- Fewer Students**

Tier 3 interventions are *highly individualized* and responsive to address the specific needs and barriers to success that students encounter.

### **TIER 3 WCCUSD climate supports**

- Re-entry conference for students returning from suspension or juvenile hall
- Site based partnerships with community based organizations (CBO's) to implement individualized interventions
- Processes for referring and identifying students in need of additional support



### **Central Interventions: Social-Emotional Safety**

### 5 centrally funded clinicians (Tier 1, 2, 3)

- Clinicians assigned to support students at sites with limited access to mental/behavioral support on site
- An additional 6 clinicians were recently hired to provide full time therapeutic, restorative and behavior support to all comprehensive middle schools

### 3 School Climate Coaches (Tier 1, 2)

• Support school sites with building out comprehensive climate and safety practices on site to support students and staff

# **Long Term Strategies**

- Continue to provide training and support for effective School Safety/Climate Teams on every campus
- Focused training and support for campus safety staff to build capacity in de-escalation and restorative practices
- Build out behavioral/mental health supports so that every student has access to a provider
- Continue the build-out of a centralized support to support student social/emotional/behavioral health








# **Year-to-date**: "Caused, Attempted to Cause, Threatened Physical Injury"




Blue - 2022-2023 SY Yellow - 2023-2024 SY


# **Detailed View of Out of School Suspensions**

The most common Major incident across all schools is (104) Possession of a Knife/Dangerous Object (n=11)





2022-2023: n=52 incidents 2023-2024: n=23 incidents

# **Takeaways from Data**

- Decrease in overall incidents of physical aggression
  Increase in the use of other-means of correction
- **Decrease** in weapons on campus
- Continue to monitor and provide intervention for behavior on campus; including:
  - Drug and vape useFighting
- Continue to use strategies from community schools framework to support building capacity of all stakeholders on site
- Continue to focus on social/emotional safety of all staff and students on campus
