I. Opening Procedures

A. Roll Call, Introductions and Land Acknowledgement

B. Approval of Agenda

II. Discussion Items

A. Dual Language Immersion (Black student experience)

Ms. Roscigno provided a brief introduction before the panel discussion around Dual Language Immersion (DLI) (black student experience), on why African American students should enroll in DLI and the number of African American students currently enrolled in DLI programs in the district. Panel discussion started with the site administrators Eric Peterson from West County Mandarin, Julie Plaisance from Stewart and Lisa Levi from Washington who answered questions on support for African American Students, support for parents and what more they would like to do for their site. Next Dual Language Immersion teachers, Maresha Johnson, Teacher of West County Mandarin; Monica Lira, Teacher at Stewart; Kristyn Jones, Teacher at Washington; Jie Ni, IB Coordinator/Teacher at West County Mandarin, answered the same questions. Then DLI parents shared their experiences and their children's experiences in the DLI program by answering what their site administrator and teacher does to help them and their children in the DLI program and what more they want done. Mr. McGee also shared thoughts on behalf of the Office of African AmericanStudent Achievement.

Trustee Gonzalez-Hoy asked questions of the panelists around some challenges that have

prevented the growth of the program to increase our African American community with the schools, what can we do better to recruit African American teachers and in particular bilingual African American teachers, thoughts on retaining our African American teachers and particularly around the bilingual program, additional things the district can do to support and grow the program within the African American community, and what are some of the causes that have led to the lack of recruiting/retaining of African American students at the longest running DLI program at Washington. Due to time constraints, he welcomes anyone to email him with any additional comments.

Trustee Smith-Folds asked questions of the panelists if testing is offered in English, Spanish or Mandarin for state and local assessments.

Motion: Trustee Gonzalez-Hoy motioned to extend the meeting to 6:40 PM. Chairperson Smith-Folds seconded. Motion carried.

Discussion:

Trustees enjoyed hearing from the parents, principals and teachers on their experience in the schools. This is one of many conversations that they want to have. Looking forward to hearing recommendations coming back from staff on a district level to support African American students and increasing the number of students to join and stay in the program and keeping our educators in this district long term. Trustees would love to see cross district collaboration between the school programs, parent and teacher groups with district personnel present to provide support. We need more promotion of the programs and can learn from the Mandarin school's efforts. Trustees would like to see more funding to help provide additional support for students, parents and staff. Trustees thanked parents, teachers and administrators for the fight that they do for their children/students. There needs to be standardization across the district for these DLI programs. This is where we create these global citizens. We need to put people in front of children that look like them and can speak other languages. We need a clear transition from Middle to High school. Everyone is invited but everyone needs to feel welcome and know that they belong in the program. Mr. Aurelio expressed his appreciation to the parents, teachers and principals.
